Since its establishment in 1976, VTech has been the pioneer in the electronic learning toy category. With advanced educational expertise and cutting-edge innovation, VTech products provide fun and learning to children around the world. Leveraging decades of success in cordless telephony, the Group's diverse collection of telecommunication products elevates both home and business users' experience through the latest in technology and design. As one of the world's leading electronic manufacturing service providers, VTech offers world-class, full turnkey services to customers in a number of product categories.

The Group's mission is to integrate economic growth, environmental protection and social responsibility in its business strategies to design, manufacture and supply innovative and high quality products for the well-being of people and benefit of society, aiming to drive sustainable value for its stakeholders and the communities.

With headquarters in Hong Kong and state-of-the-art manufacturing facilities in mainland China, Malaysia and Mexico, VTech has approximately 21,600 employees in its operations across 15 countries and regions, including about 1,500 R&D professionals in R&D centres in Hong Kong, mainland China, Germany, the US and Canada. This network allows VTech to stay abreast of the latest technology and market trends throughout the world, while maintaining a highly competitive cost structure.

VTech invests significantly in R&D and launches numerous new products each year under its portfolio of strong brands, supported by a global distribution network of leading traditional and online retailers.

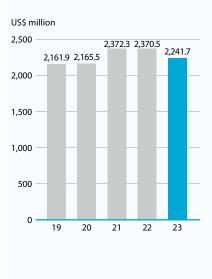

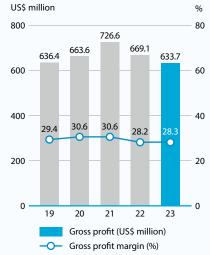

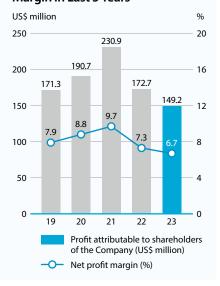
#### Group Revenue in Last 5 Years

### Letter to Shareholders



#### Dear Shareholders,

VTech reported a decline in revenue and profit for the financial year 2023, as the challenging macro-economic environment in North America and Europe resulted in lower sales of electronic learning products (ELPs) and telecommunication (TEL) products. This offset record revenue at contract manufacturing services (CMS) as the supply of critical components improved.

#### **Results and Dividend**

Group revenue for the year ended 31 March 2023 declined by 5.4% to US\$2,241.7 million, from US\$2,370.5 million in the previous financial year. Lower sales in North America and Europe offset higher sales in Asia Pacific and Other Regions. Profit attributable to shareholders of the Company fell by 13.6% to US\$149.2 million. The decline in profit was mainly attributable to the decrease in revenue combined with a higher advertising and promotional spend for ELPs and TEL products.

Basic earnings per share decreased by 13.7% to US59.1 cents, compared to US68.5 cents in the financial year 2022.

The Board of Directors has proposed a final dividend of US42.0 cents per ordinary share, providing a full-year dividend of US59.0 cents per ordinary share, a 13.2% decrease from the US68.0 cents declared in the previous financial year. This represents a dividend payout ratio of 99.9%.

#### Costs

The Group's gross profit margin in the financial year 2023 was 28.3%, as compared with 28.2% in the previous financial year. The slight increase was mainly attributable to lower cost of materials and freight charges, combined with an increase in selling prices. Direct labour costs and manufacturing overheads were also lower. However, these gains were offset by the negative impact of lower Group revenue, the depreciation of the major currencies against the US dollar, an increase in inventory provisions and a change in product mix.

#### **Our Businesses**

The operating environment in the financial year 2023 was challenging. Persistently high inflation and rising interest rates progressively eroded consumer and business confidence in North America and Europe. As consumers became more price-sensitive and reduced discretionary purchases, retailers tightened inventories and reduced orders. The strong US dollar in the first half of the financial year 2023, meanwhile, added to the pressure on retailers outside the US. As growth prospects turned uncertain, businesses also reduced their spending on new equipment. Although the supply of components improved over the course of the financial year, shortages of certain critical components continued, affecting some of the Group's products.

The unfavourable market conditions weighed on the ELPs business, which experienced sales declines in key markets. In North America and Europe, the Group's largest markets, increasingly price-sensitive consumers traded down to lower price items in response to high inflation and soaring energy prices. The weak consumer sentiment resulted in high channel inventory, which led major retailers to suspend or delay orders during the holiday season. Sales of the Group's standalone and platform products declined. However, its growing range of eco-friendly toys, Marble Rush®, electronic learning aids, the Kidi line and LeapLand Adventures™ did achieve growth. The successful launch of Magic Adventures™ Microscope also generated incremental business. Standalone products' percentage share of total ELPs revenue stood at 87% in the financial year 2023, compared to 84% in the financial year 2022.

Despite the challenges, VTech has continued to lead the way in creating innovative and age-appropriate technologies for children's learning and entertainment, as a recognised leader in electronic educational toys. In the calendar year 2022, the Group maintained its global number one position in electronic learning toys from infancy through toddler and preschool<sup>1</sup>.

Revenue from TEL products was also lower, with declines in residential phones, commercial phones and other telecommunication products. The share of commercial phones and other telecommunication products within total TEL products revenue was 57% in the financial year 2023, as compared with 59% in the financial year 2022.

The residential phone market in the US has continued to contract and shipments were constrained by the tight supply of semiconductors in the first half of the financial year 2023. The Group did, however, regain distribution in a key retailer in the US and maintained its leadership position in the US residential phone market<sup>2</sup>. In Europe, meanwhile, VTech branded cordless phones made good progress, with sales to the UK and Germany increasing.

In commercial phones, sales of hotel phones grew as a stable supply of products and new models featuring contemporary designs met with a positive response. However, SIP (Session Initiation Protocol) phones were affected by a delayed product launch, while shipments of multi-line commercial phones were constrained by semiconductor supply issues, particularly in the first half of the financial year 2023. Sales of headsets also fell as a customer reduced orders.

Other telecommunication products registered a sales decrease. CAT-iq (Cordless Advanced Technology – internet and quality) handsets and CareLine® products saw sales increases, as semiconductor supply improved in the second half of the financial year 2023. However, this was insufficient to offset lower sales of baby monitors and integrated access devices (IADs). Sales of baby monitors decreased as consumers traded down to lower price items in response to inflationary pressures, while the weaker market saw existing customers in Europe and Asia Pacific reduce orders for IADs. VTech nonetheless gained market share and maintained its position as the number one baby monitor manufacturer in the US and Canada<sup>3</sup>.

In the financial year 2023, CMS achieved record revenue despite shortages of certain critical components. The growth was mainly driven by higher market demand after the end of the COVID-19 pandemic for various product categories, which more than offset a decline in hearables. Sales increased in the majority of product categories, with especially strong growth in professional audio equipment following the post-pandemic relaxation of social distancing measures. This also benefited the Malaysian facility that produces DJ equipment, where production now exceeds pre-pandemic levels. VTech's CMS business was named by Music Trades Magazine as the world's number one contract manufacturer of professional audio equipment in the calendar year 2021<sup>4</sup>. In addition, VTech CMS ranked 28th in the world among electronics manufacturing services (EMS) providers, and first in Hong Kong, according to Manufacturing Market Insider<sup>5</sup>.

CMS continued to make great strides in the important move to Industry 4.0, which is now in the final stage of implementation at the facilities in mainland China. This is a revolution in manufacturing driven by technology, using machine learning, artificial intelligence (AI), data analytics and automation to optimise supply chains and manufacturing processes. To meet increased demand for contingency manufacturing sites outsides China, the facility in Tecate, Mexico is being upgraded to be able to offer full turnkey electronics manufacturing services.

#### Keep Steering Towards a Sustainable Future

Despite the complex and challenging operating environment the Group is facing, as a global leader in ELPs and residential telephony, as well as a world-leading CMS provider, VTech remains steadfast in its commitment to creating sustainable value to improve the lives of people and protect the planet for future generations. It achieved meaningful progress towards sustainability in the financial year 2023.

Leveraging its 47 years of excellence in technological innovation, VTech expanded its range of eco-friendly ELPs made from sustainable materials such as recycled polyethylene terephthalate (PET) bottles, reclaimed plastics and Forest Stewardship Council (FSC) certified wood. It also introduced a series of hotel phones made from recycled PET bottles. As for sustainable packaging, over 95% of the packaging materials for its ELPs was recyclable, of which about 85% was made from recycled materials. Blister was also eliminated in about 99% of ELPs packaging.

To combat climate change and reduce its impacts on the planet, VTech increased its use of renewable energy by accelerating the installation of solar panels at its manufacturing sites, and reduced volatile organic compounds (VOCs) emission through the increasing use of waterborne paint in its products and packing. On-going programmes for energy efficiency improvement, water consumption savings and waste reduction management are also in place to preserve natural resources in factory operations.

As a responsible corporate citizen, VTech is dedicated to providing a diverse, equitable and inclusive working environment for its employees. In addition to the gender diversity of its Board of Directors, about 41% of VTech's workforce was women, with 26% of management positions held by women. VTech also promotes a culture of integrity in the workplace for its employees, and engages in ethical sourcing practices with its suppliers throughout the supply chain.

Moving forward, VTech will uphold its culture of integrity, accountability and innovation to guide the company towards a sustainable future. With its solid sustainability foundation, VTech will continue to integrate economic growth, environmental protection and social responsibility in its business strategies to design, manufacture and supply innovative and high-quality products for the well-being of people and the benefit of society, aiming to drive sustainable value for its stakeholders and the communities.

#### Reorganisation of ELPs and TEL Products Operations

VTech is taking steps to reorganise its ELPs and TEL products operations. The goal is to create a stronger, leaner and more efficient organisation that can bring new products to the market faster and quickly respond to changing market conditions.

As part of this effort, the US ELPs business is undergoing a structural reorganisation, with a new leadership team that will reduce the number of management layers and downsize operations. In addition, the Group will increase the productivity of its products by improving product segmentation and portfolio management, as well as expanding license partnerships to maximise sales opportunities. The Group will also strengthen its product planning and marketing through more targeted advertising and promotional spend, enhanced marketing communications and leveraging its VTech and LeapFrog brands more effectively. To support growth further, VTech will rebuild its e-commerce team to ramp up online sales and implement measures to raise supply chain efficiency.

In order to create a leaner and more efficient TEL products business, VTech is streamlining its R&D (Research and Development) function in mainland China, tightening management and accelerating new product launches. The Group is also revitalising its go-to-market strategy for commercial phones, with dedicated teams to refocus the telecommunication service provider and the VAR (Valueadded Reseller) businesses. These initiatives demonstrate VTech's commitment to delivering innovative, high-quality products and services to ensure long-term success in the telecommunication products market.

#### Outlook

The macro-economic outlook for the financial year 2024 is uncertain, but the challenges posed by persistent inflation and high interest rates in the US and Europe look set to continue. Consumers remain price-sensitive and reluctant to make purchases, leading VTech's customers to exercise caution when placing orders and managing inventories.

In view of this, the Group targets revenue to be flat year-onyear. Profitability, however, is forecast to recover. Costs are trending down and margins will be boosted further by the actions taken at the ELPs and the TEL products businesses.

The cost trends for the financial year 2024 appear favourable. Cost of materials is expected to decrease as the recent supply issues have mostly eased, even though the supply of a relatively small number of critical components will remain tight. Direct labour costs are no longer on the rise in mainland China and there is an adequate supply of labour. Manufacturing overheads are expected to improve. Freight costs, meanwhile, have returned to pre-pandemic levels as the global economy has slowed. The only exception is that domestic transportation costs in the US and Europe remain high.

The ELPs business is striving to achieve growth in the financial year 2024, as sales in North America and Europe recover and the business extends its geographical reach.

Growth in North America and Europe will be driven by the introduction of exciting new products across all categories. Core learning products will be strengthened by the launch of new infant, toddler and preschool items, as well as the expanded license offerings. At VTech, the toddler and preschool Go! Go! Smart/Toot-Toot family of products has been completely revamped with new playsets, cars and animals. The infusion of a new licensed character, CoComelon, into this line will add further momentum. To boost growth in the preschool vehicle category, VTech will expand its popular Switch & Go® Dinos range. This recently saw the addition of new dinosaur models as well as a series of eggs that "hatch" into different dinosaurs, with more to come in this direction in the financial year 2024. The Group will also re-enter the bath and robotic toys markets to tap new avenues of growth. At LeapFrog, the focus is on

invigorating existing product categories. New core learning products will be launched. There will also be innovative variations on successful themes, such as the eco-friendly toys, Magic Adventures range and role-play toys.

In addition to new product launches, a new sales office in Italy has started operations that will add incremental sales in Europe in the financial year 2024. In Asia Pacific, the Group is expected to grow in Australia and a strong sales recovery is anticipated in mainland China following the easing of COVID-19 restrictions.

Although the uncertain market conditions make forecasting difficult, TEL products revenue is projected to be higher in the financial year 2024. Sales of commercial phones are expected to increase, with growth in the Snom D8 series of SIP desksets, the multi-cell SIP DECT (Digital Enhanced Cordless Telecommunications) mobility system and the work-from-anywhere series, as the Group rolls out these products to more markets. This will be augmented by rising sales of the hospitality category led by hotel phones, following the addition of a new, advanced wireless thermostat designed for hotels.

For residential phones, growth in Europe is expected to offset a sales decline in the US, where the market continues to contract. VTech branded residential phones are expected to continue to grow their market share in the UK and Germany, while expanding to France, Italy and Spain via online channels. This will drive an overall sales increase for residential phones.

Other telecommunication products will benefit from a recovery in baby monitors. VTech's leadership in North America will be strengthened by continued good sell-through of VTech branded products and growing sales of LeapFrog branded premium baby monitors. This will be supported by new product launches. A smart Wi-Fi baby monitor using Al technology, featuring face-covering and roll over monitoring, will hit the shelves in North America by July 2023.

CMS revenue is forecast to be stable, as customers remain cautious in placing orders and managing inventories in view of global economic uncertainties. Sales of the key product categories, namely professional audio equipment, industrial and medical and health products are expected to remain largely stable. Growth will be seen in the areas of smart energy storage systems and smart home control systems, where customers are launching new products. After a twoyear period of decline, sales of hearables are expected to stabilise. Work to complete the implementation of Industry 4.0 in the manufacturing facilities in mainland China will continue, while the Mexican facility is on track to offer full turnkey EMS capability by December 2023.

I wish to thank my fellow directors for their sound advice during the year, and all our colleagues for their dedication and hard work. I would also like to thank our customers and suppliers, who continue to co-operate with us to overcome the challenges we all face. Finally, I wish to acknowledge the support given by our shareholders and business partners.

The reorganisations underway at our ELPs and TEL products operations will result in tighter, leaner management. This will allow us to leverage our brands and core competence more effectively and develop competitive, innovative products. CMS, meanwhile, is creating a more technology-driven and globally diversified manufacturing base. Although it has been a challenging twelve months, therefore, we are confident of a solid recovery in the financial year ahead.

#### Revenue

Group revenue for the year ended 31 March 2023 decreased by 5.4% to US\$2,241.7 million compared with the previous financial year. The decrease in revenue was largely driven by the decrease in revenue in North America and Europe, which offset the higher sales in Asia Pacific and Other Regions.

#### **Gross Profit / Margin**

Gross profit for the financial year 2023 was US\$633.7 million, a decrease of US\$35.4 million or 5.3% compared to the US\$669.1 million recorded in the previous financial year. Gross profit margin for the year increased from 28.2% to 28.3%. It was mainly attributable to the increase in selling prices, lower cost of materials, freight charges, direct labour costs and manufacturing overhead during the year. These offset the negative impact of lower Group revenue, depreciation of major foreign currencies against United States Dollar, change in product mix, as well as the increase in inventory provisions arising from the Group's early production and shipments of the Group's products to its overseas warehouses in order to mitigate the higher freight costs and the risk of vessel capacity constraints during the peak season of the financial year 2023.

#### **Operating Profit / Margin**

Operating profit for the year ended 31 March 2023 was US\$180.5 million, a decrease of US\$23.3 million or 11.4% compared with the previous financial year. Operating profit margin also reduced from 8.6% to 8.1%. The reduction in both operating profit and operating profit margin was mainly due to the decrease in gross profit. Operating profit for the year also included government subsidies of US\$2.0 million in response to COVID-19, as compared with an amount of US\$0.5 million in the last financial year. The Group invests in an investment holding company which has a shareholding in a listed entity that designs and distributes integrated circuit products (the "Investment"). Other net income included a fair value loss of US\$0.3 million on this Investment, as compared with a fair value loss of US\$1.0 million in the same period last year.

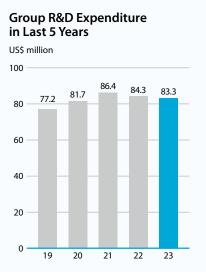
Total operating expenses for the year ended 31 March 2023 decreased from US\$464.8 million to US\$454.9 million as compared with the last financial year. Total operating expenses as a percentage of Group revenue increased from 19.6% to 20.3%.

Selling and distribution costs decreased from US\$304.9 million to US\$294.0 million compared with the same period last year. As a percentage of Group revenue, selling and distribution costs increased from 12.9% to 13.1%. It was mainly attributable to the increase in advertising and promotion costs for ELPs and TEL products as percentage of Group revenue.

Administrative and other operating expenses increased from US\$75.6 million to US\$77.6 million compared with the same period last year. It was mainly due to the increase in employee related costs. The net exchange loss arising from the Group's global operations in the ordinary course of business was US\$1.2 million, as compared with a net exchange loss of US\$0.3 million in the last financial year. Administrative and other operating expenses as a percentage of Group revenue also increased from 3.2% to 3.5%.

During the financial year 2023, the research and development expenses were US\$83.3 million, a decrease of 1.2% compared with the previous financial year of US\$84.3 million. It was mainly attributable to lower project expenses and employee related costs. Research and development expenses as a percentage of Group revenue increased from 3.6% to 3.7%.





## Profit Attributable to Shareholders and Earnings Per Share

Profit attributable to shareholders of the Company for the year ended 31 March 2023 was US\$149.2 million, a decrease of US\$23.5 million or 13.6% as compared to the last financial year. Net profit margin also decreased from 7.3% to 6.7%.

Basic earnings per share for the year ended 31 March 2023 were US59.1 cents as compared to US68.5 cents in the previous financial year.

#### **Dividends**

During the financial year 2023, the Group declared and paid an interim dividend of US17.0 cents per share, which aggregated to US\$42.9 million. The directors of the Company (the "Directors") have proposed a final dividend of US42.0 cents per share, which is estimated to be US\$106.1 million.

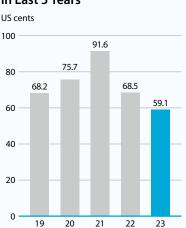
#### **Liquidity and Financial Resources**

Shareholders' funds as at 31 March 2023 were US\$634.7 million, a decrease of 6.5% from US\$678.8 million in the last financial year. Shareholders' funds per share decreased by 6.7% from US\$2.69 to US\$2.51.

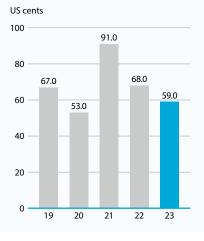
The Group had no borrowings as at 31 March 2023 and 31 March 2022.

The Group's financial position remains strong. As at 31 March 2023, the Group had net cash of US\$198.5 million, an increase of 1.4% as compared to US\$195.8 million as of 31 March 2022. It was mainly due to the lower dividend payment and the increase in net cash generated from operating activities compared with the last financial year. These offset the lower opening cash balance and the unfavourable foreign currency exchange movements on the Group's net assets as a result of the depreciation of foreign currencies against United States Dollar during the year.

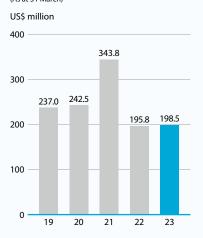
#### Basic Earnings Per Share in Last 5 Years

The Group's cash generated from operations for the year ended 31 March 2023 was US\$276.1 million, an increase of US\$94.3 million or 51.9% as compared to US\$181.8 million in the previous financial year. The increase was mainly attributable to the decrease in working capital compared with the previous financial year, which offset the lower EBITDA in the financial year 2023.

**Stocks** as of 31 March 2023 were US\$475.5 million, decreased from US\$553.3 million as of 31 March 2022. The turnover days also decreased from 131 days to 128 days. The lower stock level was largely due to the decrease in raw materials as the supply constraints had eased compared with the corresponding period of the previous financial year.

**Trade debtors** as of 31 March 2023 were US\$277.2 million, decreased from US\$325.4 million as of 31 March 2022. Debtor turnover days also decreased from 65 days to 59 days. The lower trade debtor balance as at 31 March 2023 was mainly due to the decrease in revenue in the fourth quarter of the financial year 2023 compared with the corresponding period of the previous financial year. The overdue balances greater than 30 days accounted for 1.1% of the gross trade debtors as of 31 March 2023.

**Other debtors, deposits and prepayments** as of 31 March 2023 were US\$47.1 million, decreased from US\$59.5 million as of 31 March 2022. It was mainly attributable to the decreases in fair value gain on forward foreign exchange contracts in the financial year 2023 and advance payments to suppliers.

**Trade creditors** as of 31 March 2023 were US\$252.3 million, as compared to US\$327.2 million as of 31 March 2022. Creditor turnover days decreased from 106 days to 102 days. The decrease in trade creditors was mainly due to the decrease in purchase of raw materials compared with the same period last year.

**Other creditors and accruals** as of 31 March 2023 were US\$216.2 million, decreased from US\$240.0 million as of 31 March 2022. It was largely attributable to the decreases in advance payments from customer and accruals of advertising expenses and other allowances to customers.

Provisions for defective goods returns and other

**liabilities** as of 31 March 2023 were US\$25.6 million, as compared to US\$28.3 million as of 31 March 2022.

Net assets on defined benefit scheme as of 31 March 2023 were US\$5.6 million, as compared to US\$7.4 million as of 31 March 2022. The decrease was mainly due to the re-measurement of net assets on defined benefit scheme.

#### **Treasury Policies**

The Group's treasury policies are designed to mitigate the impact of fluctuations in foreign currency exchange rates arising from the Group's global operations. The Group principally uses forward foreign exchange contracts as appropriate to hedge the foreign exchange risks in the ordinary course of business. It is the Group's policy not to enter into derivative transactions for speculative purposes.

#### **Capital Expenditure**

For the year ended 31 March 2023, the Group invested US\$27.9 million in the purchase of tangible assets including machinery and equipment, leasehold improvements, office equipment, as well as the improvement of manufacturing working environment.

All of these capital expenditures were financed from internal resources.

#### **Capital Commitments and Contingencies**

Capital commitments in the financial year 2024 for ongoing business operations are expected to be US\$40.8 million.

All of these capital commitments will be financed from internal resources.

As of the financial year end date, the Group had no material contingencies.

#### North America

Group revenue in North America decreased by 7.8% to US\$984.8 million in the financial year 2023, as lower sales of ELPs and TEL products offset an increase at CMS. North America remained VTech's largest market, accounting for 43.9% of Group revenue.

ELPs revenue in North America declined by 15.2% to US\$471.4 million, with sales decreases in the US and Canada. Both standalone and platform products registered lower sales, with declines in VTech and LeapFrog brands. Despite the challenges, VTech retained its leadership in electronic learning toys from infancy through toddler to preschool in the US<sup>6</sup>. In Canada, VTech remained the number one supplier in the infant, toddler and preschool toys category<sup>7</sup>.

In standalone products, at VTech, sales of Marble Rush and Kidi line products pushed higher, boosted by the launch of new items such as Marble Rush Corkscrew Rush Set<sup>™</sup> and My First Kidi Smartwatch<sup>™</sup>. These successes were, however, insufficient to offset lower sales of infant, toddler and preschool products, KidiZoom<sup>®</sup> cameras, Switch & Go Dinos and the Go! Go! Smart family of products. At LeapFrog, sales of LeapLand Adventures grew on the back of a new licensed version, as did the brand's growing range of eco-friendly toys made with wood, as well as plant-based and reclaimed plastics. The successful roll-out of Magic Adventures Microscope, the latest addition to the popular range of toys with a scientific learning content, also contributed additional revenue. These gains were offset, however, by lower sales of infant, toddler and preschool products.

Sales of VTech platform products declined as those of KidiZoom Smartwatch, KidiBuzz™ and Touch & Learn Activity Desk™ fell. Despite this, KidiZoom Smartwatch topped the Youth Electronics Supercategory in the US and Canada in the calendar year 2022<sup>8</sup>. LeapFrog platform products sales were lower, led by decreases in children's educational tablets, interactive reading systems and Magic Adventures Globe. Subscription revenue from LeapFrog Academy™ also declined.

During the financial year 2023, the Group's ELPs again won awards and recommendations from toy and parenting industry experts, key retailers and toy advisory boards in the US. LeapFrog's My Pal Scout Smarty Paws<sup>™</sup> was named to Walmart's "Top Toy List", while VTech Level Up Gaming Chair<sup>™</sup> and LeapFrog's Clean Sweep Learning Caddy<sup>™</sup> made *The Toy Insider's* highly coveted "Hot 20" list of toys for the holiday season. Numerous other products from both the VTech and LeapFrog ranges garnered key awards from organisations including the National Parenting Center, Autism Live Toy & Gift Guide, Mom's Choice Awards, Academic's Choice and the National Parenting Product Awards.

TEL products revenue in North America fell by 12.7% to US\$239.9 million. The decrease resulted from lower sales of residential phones, commercial phones and other telecommunication products. This was despite a further increase in sales via online channels.

Sales of residential phones fell as the US residential phone market continued to contract and shipments were hampered by the tight supply of semiconductors in the first half of the financial year 2023. Despite this, the Group regained distribution with a key retailer and maintained its leadership position in the US residential phones market<sup>9</sup>.

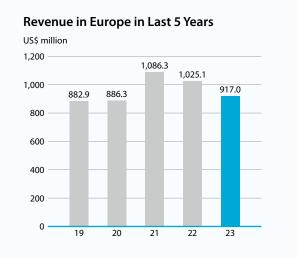
Commercial phones saw lower sales of multi-line phones, headsets and SIP phones. Production of multi-line phones was affected by tight semiconductor supply in the first half of the financial year 2023, while a major customer for headsets reduced its orders. Sales of SIP phones decreased because of a delayed product launch. These declines offset growth in hotel phones, which were buoyed by the Group's ability to maintain a stable supply of products and a well-received revamped product line featuring a more contemporary design.

Sales of other telecommunication products decreased, mainly attributable to declines in baby monitors and CareLine products. Baby monitors saw lower sales as consumers traded down to lower-priced items owing to inflationary pressure. CareLine products, meanwhile, were affected by reduced orders from a customer and lower sales of VTech branded products.

In the financial year 2023, the Group gained market share and maintained its number one position in the baby monitor market in the US and Canada<sup>10</sup>. In the US, LeapFrog's LF930HD baby monitor gained recognition in the "2022 National Parenting Product Awards", while the LF925HD model made TTPM's "Best of Baby 2022 List (Category of Baby Tech)". In Canada, VTech's BC8313 V-Hush™ Pro Sleep Training Soother and RM5764HD baby monitor, as well as LeapFrog's LF815HD baby monitor, gained "Parent Tested Parent Approved Seal of Approval" awards.

CMS revenue in North America increased by 14.9% to US\$273.5 million. Higher sales of professional audio equipment and industrial products offset a sales decline for solid-state lighting. Professional audio equipment benefited from the continuing rebound after the COVID-19 pandemic, as demand for power amplifiers and loudspeakers rose. The growth of industrial products was driven by more orders for printed circuit board assembly (PCBA) for coin and note recognition machines. Sales of solid-state lighting registered a decline as a major customer reduced its order, while sales of medical and health products remained stable. During the financial year 2023, the business acquired new customers in IoT (Internet of Things) products and professional audio equipment, respectively for smart home control systems and audio interface accessories for electronic drums.

#### Europe



Group revenue in Europe fell by 10.5% to US\$917.0 million in the financial year 2023. The decrease was due to lower sales of ELPs and CMS, which offset higher sales of TEL products. Europe was the Group's second largest market, representing 40.9% of Group revenue.

ELPs revenue in Europe decreased by 12.0% to US\$330.1 million, with declines for both standalone and platform products. Sales declined in the Group's key European markets, namely France, the UK, Germany and the Netherlands. In the calendar year 2022, VTech remained the number one infant and toddler toys manufacturer in France, the UK, Germany, Spain and the Benelux countries<sup>11</sup>.

In standalone products, VTech recorded higher sales of Marble Rush, electronic learning aids and eco-friendly toys. However, these were insufficient to compensate for lower sales of infant, toddler and preschool products, KidiZoom cameras, the Kidi line and the Toot-Toot family of products. At LeapFrog, sales posted a slight increase as growth in eco-friendly toys and LeapLand Adventures offset declines in infant, toddler and preschool products. The launch of Magic Adventures Microscope added incremental business.

#### Management Discussion and Analysis – Review of Operations

For platform products, sales at both VTech and LeapFrog brands fell. The decline at VTech was mainly attributable to lower sales of children's educational tablets, KidiZoom Smartwatch, the KidiCom<sup>®</sup> range of products and Touch & Learn Activity Desk. For LeapFrog, higher sales of Magic Adventures Globe were insufficient to offset lower sales of interactive reading systems.

During the financial year 2023, VTech and LeapFrog ELPs won numerous awards across the region. These included four "Grand Prix du Jouet 2022" awards given by La Revue du Jouet magazine in France, where Magic Adventures Microscope won "Toy of the Year". In the Netherlands, Magic Adventures Microscope gained a "Toy of the Year Award 2022" from the Dutch Toy Association. In Spain, KidiZoom PrintCam<sup>™</sup> and Magic Lights 3D were chosen as "Best Toy of the Year 2022" by the Spanish Association of Toy Manufacturers. In Belgium, Magic Adventures Microscope and Smart Chart Medical Kit<sup>™</sup> were both named "Toy of the Year 2022" by the Belgian Federation of Toys. In the UK, Rainbow Learning Lights Mixer<sup>™</sup> made the "Toy Fair Hero Toys List 2023" at the British Toy & Hobby Association while the drawing robot JotBot was named one of the "Top Ten Toys for Christmas 2022" by retailer John Lewis.

Revenue from TEL products in Europe rose by 2.8% to US\$96.4 million. Growth in residential phones and other telecommunication products offset a sales decline in commercial phones.

Sales of residential phones increased, as VTech branded phones continued to grow in the UK and Germany, and several ODM (Original Design Manufacturing) customers increased orders. Other telecommunication products also achieved a sales increase. The Group was able to meet demand for CAT-iq handsets as the supply of semiconductors improved. This offset lower sales of baby monitors, CareLine products and IADs. During the financial year 2023, VTech baby monitors and V-Hush sleep trainers garnered three "2023 MadeforMums Awards", three "2022 Loved by Parents Awards" and two "2022 Dadsnet Product Awards" in the UK.

By contrast, sales of commercial phones fell as growth in hotel phones was offset by declines in SIP phones and headsets. Hotel phones grew as the series with revamped designs was well-received by customers, while sales of SIP phones and headsets were negatively impacted by the economic slowdown in the region. CMS revenue in Europe declined by 11.8% to US\$490.5 million, as lower orders of hearables and communications products offset gains in other categories.

Sales of hearables declined because orders for a customer's Bluetooth headsets decreased as end-market demand fell due to competition, while demand for commercial headsets returned to normal levels. Sales of communication products decreased as orders for Wi-Fi routers no longer benefited from the surge in upgrading that had occurred during the COVID-19 pandemic. Professional audio equipment grew on a recovery in demand for audio mixers as events recovered with the return of normal social life. IoT products saw higher sales of smart meters as installation resumed in the UK, while demand for internet-connected thermostats and air-conditioning controls rose in response to soaring energy prices. Medical and health products saw sales of hearing aids increase, as business activity resumed after the pandemic. This offset a decline in hair removal products. Sales of home appliances remained stable, while the power supplies category saw growth from smart energy storage systems.

### Asia Pacific



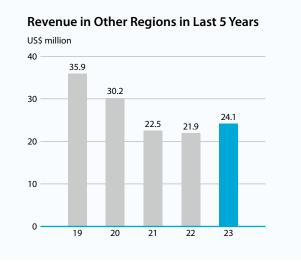
Group revenue in Asia Pacific rose by 23.8% to US\$315.8 million in the financial year 2023, as higher sales of TEL products and CMS offset lower revenue from ELPs. The Asia Pacific region represented 14.1% of Group revenue.

Revenue from ELPs in Asia Pacific decreased by 5.4% to US\$79.4 million, as growth in Japan was unable to offset lower sales in mainland China. Sales in Australia, meanwhile, held steady. The increase in Japan was driven by rising sales to a major toy retailer and good sell-through of jointly developed Smartwatches featuring the popular Japanese "Sumikkogurashi" and "Doraemon" characters. In Australia, sales held steady despite tougher market conditions. In the financial year 2023, VTech maintained its position as the number one manufacturer in the infant and toddler toys category in the country<sup>12</sup>. Four products won awards at the Australian Toy Fair in March 2023, with Magic Adventures Microscope named "Overall Product of the Year" by the Australian Toy Association. In mainland China, sales were lower as higher online sales were insufficient to offset a sales decline in offline channels. This was despite the successful roll-out of Marble Rush and the strong performance of Magic Adventures Globe in the market.

TEL products revenue in Asia Pacific increased by 2.5% to US\$28.4 million, as higher sales in Japan offset lower sales in Australia and Hong Kong. The growth in Japan was due to more orders of CareLine products from an existing customer. In Australia, sales of residential phones declined as the market shrank, while sales of baby monitors were held back by semiconductor shortages, particularly in the first half of the financial year 2023. Hong Kong, meanwhile, was affected by reduced orders of IADs from a customer.

CMS revenue in Asia Pacific rose by 45.0% to US\$208.0 million. Sales of professional audio equipment, medical and health products and communication products were higher. Professional audio equipment benefited from a rebound in sales of DJ equipment, as the Group's Malaysian facilities returned to full production following disruptions during the COVID-19 pandemic. Sales of medical and health products also increased. Orders for diagnostic ultrasound systems continued to rise as hospitals rebalanced budgets away from COVID-19 related equipment purchases. In communication products, orders for marine radios increased following a product redesign incorporating components not in short supply.

#### **Other Regions**



Group revenue in Other Regions, comprising Latin America, the Middle East and Africa, grew by 10.0% to US\$24.1 million in the financial year 2023. The increase came as higher sales of TEL products offset declines for ELPs and CMS. Other Regions accounted for 1.1% of Group revenue.

ELPs revenue in Other Regions decreased by 3.7% to US\$10.5 million. Higher sales in the Middle East were unable to offset declines in Latin America and Africa.

TEL products revenue in Other Regions rose by 24.8% to US\$13.6 million. The growth was attributable to sales increases in Latin America and the Middle East, which offset a decline in Africa.

CMS revenue in Other Regions was immaterial in the financial year 2023.

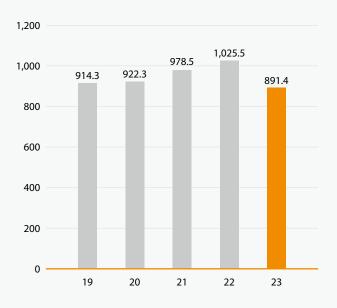

#### Sustainability Awards and Recognition

VTech's contributions to sustainability have received local and international recognition. VTech Holdings Limited has continued to be a constituent of both the Hang Seng Corporate Sustainability Benchmark Index with an AA rating, and the FTSE4Good Global Index for eight consecutive years. It has also received an A rating in the MSCI (Morgan Stanley Capital International) ESG Ratings assessment<sup>13</sup>.

#### **Board's Leadership on Sustainability**

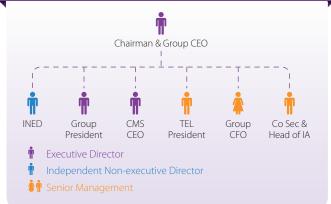

RSMC is delegated with the authority from the Board to provide vision and strategic direction for the Group's sustainability activities to ensure that they stay on track and in balance with the three sustainability dimensions of economic, environmental and social impacts at all times.

With the Company's determination and commitment towards sustainability, VTech will continue to implement comprehensive programmes to achieve its sustainability targets for its 5-year Sustainability Plan 2025. VTech also strives to integrate economic growth, environmental protection and social responsibility in its strategic business plan, aiming to drive sustainable value for its customers, employees, shareholders, investors, suppliers and the communities.

## **Stakeholder Engagement**

Stakeholder engagement is the process through which VTech stays connected with its customers, employees, shareholders, investors, suppliers and the wider communities in which it operates. VTech believes that the approach of stakeholder engagement is integral to the development of its sustainability strategy, and is also a prerequisite for its longterm sustainable growth.

During the engagement process, VTech's Sustainability Sub-Committees identify the broad topics that the stakeholder groups are concerned with, and use a materiality matrix to assess the material topics identified by its stakeholders. A topic is classified as material when it substantially affects the Group's long-term commercial or operational viability, with material impacts on economic, environmental or social topics. This matrix combines VTech's approach to identifying and assessing the material concerns of its stakeholders, and its own materiality scoring methodology by following the principles outlined in the Global Reporting Initiative (GRI) Standards.

## Sustainability Report and Disclosure

VTech has annually published its Sustainability Report since the financial year 2014. The purpose of the report is not only to communicate its sustainability strategies, management approaches and performances with its stakeholders, but also comprehensively introduce its ongoing activities for the sustainable development towards the societies and environment in which it operates.

VTech has followed the GRI Standards and its principles of balance, comparability, accuracy, timeliness, clarity, verifiability, completeness and sustainability context for the Group's sustainability report preparation. VTech has also made reference to the Stock Exchange of Hong Kong Limited (the Stock Exchange) Environmental, Social and Governance (ESG) Reporting Guide (ESG Guide) to define the report content and satisfy its "comply or explain" provisions.

Furthermore, VTech has disclosed climate-related initiatives and measures by using the framework of Task Force on Climate-related Financial Disclosures (TCFD). A number of potential physical and transition risks and opportunities related to the climate change, which have impacts on the Company in short, medium and long term, have been identified with development of sustainability initiatives to address in the 5-year Sustainability Plan.

## **Awards and Recognition**

VTech's contributions to sustainability have received local and international recognition. VTech Holdings Limited has continued to be a constituent of both the Hang Seng Corporate Sustainability Benchmark Index with an AA rating, and the FTSE4Good Global Index for eight consecutive years. VTech achieved a rating of A in the Morgan Stanley Capital International (MSCI) ESG Ratings. The VTech 2022 Annual Report and Sustainability Report won the "Excellence Report Award" and "Best ESG Reporting Award" respectively at the Best Annual Reports Awards organised by the Hong Kong Management Association. VTech was presented the "Gold Award" in the "Most Sustainable Companies/Organisation Awards" by the Hong Kong Institute of Certified Public Accountants, the "Award of Excellence in ESG" by the Chamber of Hong Kong Listed Companies, and the "ESG Leading Enterprises Award" by Bloomberg Businessweek/Chinese Edition. VTech received the "Outstanding Caring Award (Enterprise Group)" in the Industry Cares Recognition Scheme organised by the Federation of Hong Kong Industries. It has been designated a "Caring Company" by the Hong Kong Council of Social Service for fifteen consecutive years.

The Board of Directors (the "Board") and the management of VTech Holdings Limited ("VTech" or the "Company") are committed to good corporate governance and the application

of the principles including transparency, accountability and independence to achieve sustainable performance of the Company and enhance its value for the shareholders.

VTech and its subsidiaries (the "Group") also recognise that a comprehensive corporate governance management structure is crucial in helping the Company to implement its strategies and policies effectively and consistently throughout the Group, and safeguard the long-term interests of its shareholders. The Group has also continuously reviewed its policies and procedures to ensure that it meets the requirements of the applicable laws and regulations, industry best practices, global trends, and market expectations. This Corporate Governance Report will also explain how the Group applies the principles of good corporate governance as set out in the Corporate Governance Code, so as to enable the shareholders of the Company to evaluate such application.

## **Corporate Governance Practices**

VTech Holdings Limited is incorporated in Bermuda and has its shares listed on the Stock Exchange. The corporate governance rules applicable to the Company are the Corporate Governance Code (the "Code") set out in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules"). Throughout the financial year ended 31 March 2023 ("FY2023"), the Company has complied with all the code provisions of the Code, except for the deviation from code provision C.2.1 of Part 2 of the Code as described below. Under code provision C.2.1 of Part 2 of the Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. Dr. Allan WONG Chi Yun has the combined role of Chairman and Group Chief Executive Officer. As more than half of the Board members are Independent Non-executive Directors, the Board considers that this structure will not impair the balance of power and authority between the Board and the management of the Group. Furthermore, as Dr. Allan WONG Chi Yun is the founder of the Group and has substantial professional experience in the industry, the Board believes that the appointment of Dr. Allan WONG Chi Yun to the combined role of Chairman and Group Chief Executive Officer is beneficial to the sustainable development of the Group, and for the long-term interests of the shareholders.

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") set out in Appendix 10 to the Listing Rules regarding securities transactions for both its Directors and senior management. After having made specific enquiries, all Directors and senior management confirmed that they have complied with the required standard of dealings set out in the Model Code throughout FY2023.

VTech is also committed to following the Environmental, Social and Governance ("ESG") Reporting Guide set out in Appendix 27 of the Listing Rules. VTech Sustainability Report is made available for public on sustainability.vtech.com/reports\_policies. A summary of the 2023 Sustainability Report is provided on pages 34 to 36 of this Annual Report.

## VTech Code: Compliance and More

During FY2023, VTech has certain corporate governance practices exceeding the compliance requirements in the following areas:

#### Our Board

- Our Board comprises nine Directors, of which five are Independent Non-executive Directors, exceeding the requirements of the Listing Rules that at least one-third of the Board (and not less than three Directors) shall be Independent Non-executive Directors.
- All members (instead of just majority of members) of the Audit Committee and the Remuneration Committee are Independent Non-executive Directors.
- VTech conducts regular evaluation on the performance of the Board and its Committees since 2017. A summary of the evaluation results is presented to the Board for review and discussion, and presented to the respective Board Committees for follow-up.

## **Our Disclosures**

- VTech announces its interim financial results within 1.5 months after the end of the 6-month financial period, and its annual financial results within 2 months after the end of the financial year. It also publishes its Interim Report within 2 months after the end of the 6-month financial period, and publishes its Annual Report and Sustainability Report on its website and sends its Annual Report to the shareholders within 3 months after the end of the financial year. The announcement and publication periods are shorter than the minimum requirements stipulated in the Listing Rules.
- VTech's Continuous Disclosure Policy has been established since 2013 and published on its website. The policy guides the Group in monitoring and disclosing potential inside information.

#### **Our Other Practices in Corporate Governance**

- In addition to the Directors, VTech has adopted the Model Code regarding securities transactions for its senior management. This includes the implementation of clearance and approval procedures, as well as the prohibition periods for dealing in VTech securities. Senior management is required to declare that they have complied with the Model Code throughout the relevant financial year twice a year.
- At each of the AGMs held by the Company since 2017, VTech has sought the shareholders' approval for a general mandate (the "Issue Mandate") to be granted to the Directors to issue new shares of the Company up to 10% of the issued share capital of the Company, which was lower than the maximum limit of 20% as prescribed under the Listing Rules; and, if applicable, with a discount of not more than 10% to the "benchmarked price" (with reference to the Listing Rules), which was also lower than the maximum limit of 20% discount for relevant transactions as prescribed under the Listing Rules.
- Starting from the AGM held by the Company since 2018, VTech has no longer proposed to extend the relevant Issue Mandate granted to the Directors to allot, issue and deal with the additionally issued new shares (with a maximum of 10% of the issued share capital of the Company) to be repurchased by the Company.

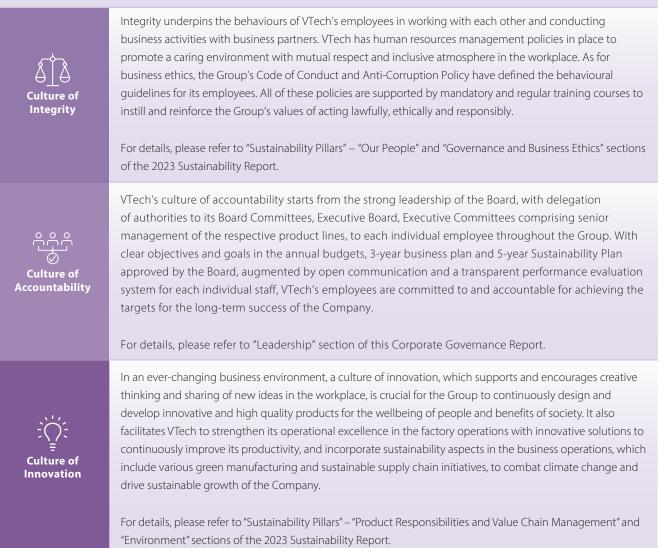
## **Corporate Governance Framework**

VTech operates within a clear and effective corporate governance structure. A strong corporate governance framework not only supports the Board and Board Committees to realise the business strategies for the long-term success of the Company, but also facilitates effective and efficient decision-making by the Board and Board Committees. In addition, the framework ensures that both Directors and employees would act within a robust chain of delegated authorities and powers, which could safeguard the compliance with the applicable laws and regulations.

#### VTech's Culture and Values

VTech's vision is to create sustainable value to improve the lives of people and protect the planet for future generations. This vision guides the Group to pursue its mission to integrate economic growth, environmental protection and social responsibility in its business strategies to design, manufacture and supply innovative and high quality products for the wellbeing of people and benefits of society, aiming to drive sustainable value for its stakeholders and the communities.

A healthy corporate culture across the Group is vital for the Company to achieve its vision and mission towards sustainable growth. At VTech, it is the Board's role to foster a corporate culture with three core principles (as set out below) to guide the behaviours of its employees, and ensure that the Company's vision, values and business strategies are aligned to it.

## **Board's Focus and Activities**

The Board is responsible for ensuring the effectiveness of the Group's corporate governance framework throughout the Company. It also recognises that effective oversight and leadership over the businesses and affairs of the Company focusing on the following areas are critical to the sustainable development of the Company:



During FY2023, the Board examined and discussed the following items in respect of the five focused areas:

#### Formulation of Business Strategies and Policies

The Board undertook an in-depth and comprehensive review of the Group's strategies. It covered the Group's position in the Company's major markets and product lines, leading drivers of change in the industry and markets, and development of product innovation and marketing strategies to seize business opportunities. As part of the 3-year business plan and budget review process, the Board considered and approved the Group's 3-year business plan for the financial year ending 31 March 2024 to 31 March 2026 and budget for the financial year ending 31 March 2024.

#### **Risk Management and Internal Control**

The Board acknowledges that it is responsible for reviewing the risk management and internal control systems. As such, the Board, through the Audit Committee and the Risk Management and Sustainability Committee, reviews the overall effectiveness of the Group's system of internal control over financial, operational and compliance issues, risk management process, information systems security and effectiveness of financial reporting and compliance with the Listing Rules.

#### Leadership and People

Human resources management including leadership succession plan is crucial to the Company's long-term success. The Board continuously reviews the Group's human resources management progress to attract, develop, retain and motivate key talents across the whole organisation. It also encourages management to train the future generation with the ability to navigate through the challenging environment and engage with important stakeholders of the Group.

## **Performance Monitoring**

The Board approved the Group's Annual Report for FY2023 and the Group's Interim Report for the six months ended 30 September 2022. In approving the Annual Report and Interim Report, the Board also approved the financial statements and ensured that the statements gave a true and fair view of the financial position of the Group.

#### **Stakeholders Engagement**

Stakeholder engagement is the process through which we stay connected with our customers, employees, shareholders, investors, suppliers, business partners and the wider communities in which we operate. In order to strengthen the Company's market leadership in the businesses demanding technological advancement, the Board members and management exchanged opinions and agreed on the strategic direction to engage younger generation in product innovation and development. The Company also actively engages with its shareholders and investors through physical and virtual meetings as well as investment conferences to provide timely information of the Group's business performance and development.

### (1) Leadership

#### Board of Directors

The Board is responsible for the stewardship of the Group, overseeing its conduct and affairs to create sustainable value for the benefits of its shareholders, and for the long-term success of the Company.

Except for the matters reserved for the Board decisions, which affect the Company's overall strategic policies, financial position and shareholders, the Board may delegate part of its functions and duties as well as the day-to-day operational responsibilities to the Executive Board and Executive Committees, specifying matters which require approval by the Board in accordance with the Group's approval policy.

Matters reserved for the Board decisions include, but not limited to, the following:

- deliberation of 3-year business plans, risk management, internal control, sustainability strategies, activities and performance progress against the sustainability target;
- preliminary announcements of interim and final results, interim and annual reports, and sustainability reports;
- dividend policy;
- annual budgets;
- major corporate activities such as material acquisitions and disposals, and connected transactions; and
- Directors' appointment, re-election and removal.

## Board Composition

The Board currently comprises three Executive Directors, one Non-executive Director and five Independent Non-executive Directors. The Board considers that the composition is well balanced in terms of experience, competencies, expertise, diversity and skills, with a strong independent element ensuring the impartially of the Board's decision making process and oversight of the management. The Independent Non-executive Directors are executives of high calibre with diversified industry expertise and bring a wide range of skills and experience to the Group. They bring to the Company independent judgement on issues of strategy, performance, risk and human resources management through their contribution at Board meetings.

#### Changes to Board and Board Committees

VTech recognises the importance of diversity among its Board members. During FY2023, the Nomination Committee reviewed the structure, size and diversity of the Board and recommended to the Board for the Board to consider the appointment of a new Independent Non-executive Director. To enhance the gender diversity of the Board, the Board appointed a new female Director, Professor GAN Jie to the Board as an Independent Non-executive Director and a member of the Audit Committee pursuant to the Company's Board Diversity Policy and the Nomination Policy during FY2023. Professor GAN Jie brings with her many years of extensive experiences in both technology innovation and finance to the Company. Her areas of expertise include corporate finance, asset management, Chinese industrial economy, financial regulation, stock markets and entrepreneurship, which enable her to provide valuable and independent guidance to the Board and the Company.

The Board has four Board Committees, namely the Audit Committee, the Nomination Committee, the Remuneration Committee and the Risk Management and Sustainability Committee. The Board has delegated authority to various Board Committees to deal with specific matters. The Audit Committee, the Nomination Committee, the Remuneration Committee, and the Risk Management and Sustainability Committee were established with defined terms of reference which are no less exacting than those set out in the Code. The composition and terms of reference of the Board committees are reviewed and updated periodically to ensure that they remain appropriate and in line with the Group's business and changes in governance practices.

## Executive Board

Executive Board consists of three Executive Directors. It is responsible for overseeing the daily operations of the Group under the Board's delegation with support from senior management to review and manage the business, operational and financial performance as well as risk management and internal control of the Group. As for the responsibilities of day-to-day operations, except for the specific matters which require the approval by the Executive Board in accordance with the Group's approval policy, they are delegated from the Executive Board to the Executive Committees and senior management of the respective product lines. The members of the Executive Committees are also responsible for ensuring that a similar process of delegation is in place within his or her department or responsible areas.

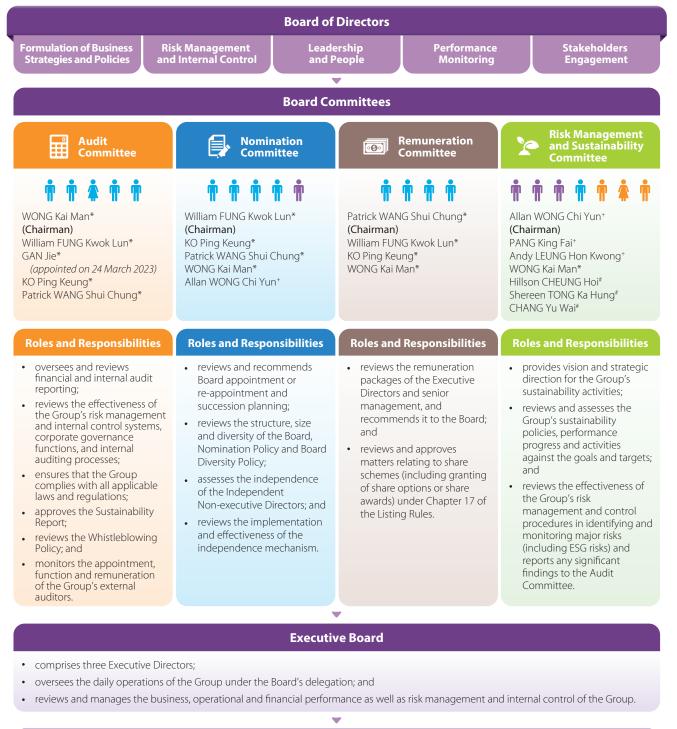
## Executive Committees

Executive Committees members include the Executive Director(s), President(s) and senior management of the respective product lines appointed by the Executive Board from time to time. Day-to-day management of the product lines is delegated from the Executive Board to the Executive Committees of the respective product lines in accordance with the Group's approval policy. The Board retains control of the key decisions and certain "reserved matters" which will be reviewed annually.

## Board Evaluation

The Board recognises the importance and benefits of conducting regular evaluation of its performance. In addition to the ongoing review by the Nomination Committee on the composition and structure of the Board, the Board has adopted a structured process to evaluate its own performance and Directors' contribution every two years since 2017.

The Board evaluation was conducted in the form of questionnaire by all members of the Board and Board Committees with the aim of improving the effectiveness of the Board and the Board Committees. The scope of the evaluation focused on the composition and diversity, as well as effectiveness of the performance of the Board and the Board Committees. The evaluation questionnaire consisted of both quantitative element based on the ratings to each question, as well as qualitative recommendations on any areas of improvement.

A summary of the 2023 evaluation results, which was anonymous and prepared by the Company Secretary, was presented to the Board for review and discussion at the Board meeting in May 2023. The summary indicated that the members of the Board and Board Committees broadly agreed that the Board and Board Committees had operated satisfactorily. They were also satisfied, in general, with the composition and effectiveness of each Board Committee. The evaluation results with recommendations were also presented to the respective Board Committees for their follow-up actions of improvement.

### Board Diversity

As for the diversity of the Board, the Directors were satisfied, in general, with diversity of the Board and each Board Committee in accordance with the Board Diversity Policy, which requires the review by the Nomination Committee annually. The Directors also recognised that the Board diversity could be further enhanced in the areas of gender and age group. The Nomination Committee has achieved the target set for FY2023 to identify suitable candidate to enhance the gender diversity of the Board and to have at least one female Board member. During FY2023, the Board accepted the nomination by the Nomination Committee and appointed a new female Director to the Board. The Board would continue to take initiatives to identify suitable candidates to strengthen the Board diversity and targeted to at least maintain the current level for female representation of the Board. To develop a pipeline of potential successors to the Board to achieve gender diversity, the Nomination Committee will select appropriate candidates through various channels and make recommendation to the Board based on the Board Diversity Policy and the Nomination Policy of the Company. For further details of the Board Diversity Policy and Nomination Policy, please refer to the section headed "Nomination Committee Report".

VTech has also taken, and continues to take steps to promote diversity at all levels of its workforce. It has a Human Rights Policy with risk management programme in place to protect and safeguard the human rights of its stakeholders including the employees. The Group provides equal opportunity to all employees and does not discriminate on the grounds of gender, race, age, nationality, religion, sexual orientation, disability and any other aspects of diversity. It has target to achieve the percentage of women in management positions at or above 25%. In FY2023, VTech's global workforce consisted of 41% women, with 26% of management positions held by women. For details of the Group's Human Rights Policy, please refer to the "Respect of Labour and Human Rights" section of the 2023 Sustainability Report.

## Appointment and Re-election of Directors

All Directors (including the Non-executive Director and the Independent Non-executive Directors) are appointed for a specific term of three years and are subject to retirement by rotation and re-election at least once every three years at the AGMs under the Company's Bye-laws. In accordance with the Company's Bye-laws, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation. In addition, any Directors appointed by the Board during the year, either to fill a casual vacancy or as an addition to the Board, shall hold office until the next AGM and shall be subject to retirement by rotation. A formal letter of appointment is issued to the Directors who were appointed or re-elected during the year. The letter deals with the specific terms of appointment and a range of matters regarding Director's appointment and responsibilities.

### Board Independence

As at 31 March 2023, five out of nine Directors were Independent Non-executive Directors, exceeding the requirements of the Listing Rules that at least one-third of the Board (and not less than three Directors) shall be Independent Non-executive Directors.

#### Mechanism to ensure Independent views and Input

In order to ensure that independent views and input of the Independent Non-executive Directors are made available to the Board, the Nomination Committee and the Board are committed to assessing the Directors' independence annually with regards to all relevant factors related to the Independent Non-executive Directors including the following:

- required character, integrity, expertise, experience and stability to fulfill their roles;
- time commitment and attention to the Company's affairs;
- firm commitment to their independent roles and to the Board;
- declaration of conflict of interest in their roles as Independent Non-executive Directors;
- cross directorships or significant links with other Directors;
- no involvement in the daily management of the Company nor in any relationship or circumstances which would affect the exercise of their independent judgement;
- further re-appointment of an Independent Nonexecutive Director (including the long-serving Independent Non-executive Director) is subject to a separate resolution to be approved by the shareholders; and an assessment on whether the Independent Nonexecutive Director is still independent and should be re-elected;
- Chairman meets with the Independent Non-executive Directors regularly without the presence of the Executive Directors and Non-executive Director;
- independent professional advice, as and when required by the Director; and
- Independent Non-executive Director as the chairman of the Audit Committee, the Nomination Committee and the Remuneration Committee.

### Conflict of Interest

Directors are requested to confirm the direct or indirect interests of their and their connected entities, if any, in proposals or transactions to be considered by the Board at Board meetings and withdraw from the meetings as appropriate. During FY2023, none of the Directors were required to withdraw from meeting in these circumstances.

#### Independence

The Board has received from each Independent Nonexecutive Director a written annual confirmation of their independence pursuant to Rule 3.13 of the Listing Rules. The Board considers that the five Independent Non-executive Directors are independent in character and judgement and they also meet the independence criteria set out in Rule 3.13 of the Listing Rules. The written annual confirmation from each of the Independent Non-executive Directors of his independence also covered his immediate family members (as defined under the Listing Rules).

The Nomination Committee and the Board have also taken into account the respective contributions to the Board of the Independent Non-executive Directors.

Dr. William FUNG Kwok Lun has diversified industry experience, brings a wide range of skills and experience to the Group and provides valuable insight and independent advice to the Board and the Company in particular on the areas of logistics and supply chain operations and dealings with global markets.

Professor GAN Jie has extensive experience in both technology innovation and finance. Her areas of expertise include corporate finance, asset management, Chinese industrial economy, financial regulation, stock markets and entrepreneurship, which enable her to provide valuable and independent guidance to the Board and the Company.

Professor KO Ping Keung has vast knowledge and experience in wide spectrum of technologies, especially in areas such as advanced integrated circuits and information technology and his connections with advanced technology providers and start-up companies of all sizes, especially in China, continue to provide great benefit to the Board and the Company.

Dr. Patrick WANG Shui Chung has vast international experience with extensive knowledge in the manufacturing industry and a deep understanding of the environment in which the Company operates, which enable him to provide valuable insight and advice to the Board and the Company.

Mr. WONG Kai Man's strong finance, accounting and tax expertise and his firm commitment to his independent role enable him to provide key strategic guidance to the Board and the Company in areas such as financial review, risk management, compliance and internal control.

The wide breath of knowledge and diversity of their experience make each of the Independent Non-executive Directors invaluable members of, and active contributors, to the Board. Moreover, they do not hold any cross-directorships or have any significant links with other Directors through involvement in other companies or bodies that could give rise to conflicts of interest in their roles as Independent Non-executive Directors and they are not involved in the daily management of the Company nor in any relationships or circumstances which would affect the exercise of their independent judgment. They continue to demonstrate their ability to provide an independent, balanced and objective view to the affairs of the Company.

The Nomination Committee was satisfied that each of the Independent Non-executive Director has the required character, integrity and experience to fulfill the role of an Independent Non-executive Director.

Notwithstanding that some Independent Non-executive Directors have served on the Board for more than nine years, the Nomination Committee and the Board are of the view that this does not and would not affect their independent judgement as each of the Independent Non-executive Director has been providing objective views and independent opinions to the Company over the years. In addition, they have continued to show devotion and a firm commitment to their independent roles and to the Board that they are able to devote sufficient time and attention to the Company's affairs and confirm that they will continue to demonstrate their commitment to their roles.

Any further re-appointment of an Independent Non-executive Director (including the long-serving Independent Nonexecutive Director) is subject to a separate resolution to be approved by the shareholders. Reasons will be given in the circular to shareholders to explain why the Board believes the Independent Non-executive Director is still independent and should be re-elected. If the proposed Independent Non-executive Director will be holding his seventh (or more) listed company directorship, the Board will explain in the circular why the proposed Independent Non-executive Director will still be able to devote sufficient time to the Board.

Taking into account all of the circumstances described above, the Board and the Nomination Committee believe that each of the Independent Non-executive Directors continues to be independent and provides invaluable and independent advice to the Board through their extensive knowledge and experience that enhance the diversified representation of the Board.

#### Board, Board Committees and Shareholders' Meetings

Four Board meetings at approximately quarterly intervals are scheduled during FY2023 with other meetings held as required. Dates of regular Board meetings and Board Committees meetings are scheduled in the prior year to facilitate maximum attendance of Directors. All Committees' meetings are conducted prior to the Board meetings to ensure that all vital matters are reported to the Board in advance and decided upon by the Board in a timely manner. The draft agenda for regular meetings of the Board and Board Committees is usually sent to the Directors at least 14 days before the intended date of the meetings. Directors are advised to inform the Chairman of the Board and Board Committees before the meeting if they wish to include any matters in the agenda. The agenda together with the Board papers are usually sent to the Directors at least 3 days before the meetings.

Minutes of the meetings of the Board and Board Committees record in sufficient detail the matters considered by the Board and Board Committees, the decisions reached, including any concerns raised by Directors or dissenting views expressed. Draft and final versions of the minutes of the Board meetings and the Board Committees meetings are sent to all Directors or respective Board Committees members for their comment and records within a reasonable period after the meetings are held. Minutes of the Board meetings and the Board Committees meetings are kept by the Company Secretary of the Company (the "Company Secretary"). All Directors have access to the advice and services of the Company Secretary and independent professional advice may be sought by the Directors if required.

#### Responsibilities in respect of Financial Statements

The Directors are responsible for overseeing the preparation of the consolidated financial statements for FY2023 to give a true and fair view of the financial position of the Group as at that date and of its financial performance for the year then ended. In doing so, the Directors have adopted the appropriate accounting policies, applied them consistently in accordance with the International Financial Reporting Standards and made judgements and estimates that are prudent and reasonable in preparing the consolidated financial statements on the going concern basis.

The Directors are responsible for ensuring the maintenance of proper accounting records, safeguarding of the assets of the Company and taking reasonable steps for the prevention and detection of fraud and other irregularities.

The management shall provide the Board with monthly updates giving a balanced and understandable assessment of the Company's performance, position and prospects in sufficient detail.

The statement by the external auditor of the Company regarding their responsibilities on the consolidated financial statements of the Group is set out in the Independent Auditor's Report on pages 90 to 93 of this Annual Report.

## Company Secretary

The Company Secretary is an employee of the Company, reports to the Chairman and is responsible for providing advice to the Board for ensuring the Board procedures are followed. The Company Secretary has taken no less than 15 hours of relevant professional training and has duly complied with the training requirement under Rule 3.29 of the Listing Rules.

### Internal Control

The Directors have the overall responsibility for internal control, including risk management, and set appropriate policies having regard to the objectives of the Group. During FY2023, the Board, through the Audit Committee and the Risk Management and Sustainability Committee, reviewed the overall effectiveness of the Group's system of internal control over financial, operational and compliance issues, risk management process, information systems security and effectiveness of financial reporting and compliance with the Listing Rules.

#### Internal Control – Internal Control System

The Group's internal control systems aim at safeguarding assets from inappropriate use, maintaining proper accounts and ensuring compliance with regulations. The management is primarily responsible for the design, implementation and maintenance of the internal control systems. The system is designed to provide reasonable, but not absolute, assurance against misstatement or loss, and to manage risks of failure in the operation of the Company. The Company has an internal audit function which monitors the effectiveness of the system and the procedures for monitoring by key operations.

The Group has put in place an organisational structure with formal and clearly defined lines of responsibility and delegation of authority. There are also established procedures for financial planning, capital expenditure, treasury transactions, information and reporting systems, and monitoring the Group's businesses and their performance.

## Internal Control – Internal Audit Department

The Group's Internal Audit Department has been established for more than 20 years and the Internal Audit Department has direct access to the Audit Committee. The Internal Audit Department reviews the effectiveness of the internal control systems. Every three years, the Internal Audit Department carries out a risk assessment on each identified audit area and devises a three-year audit plan according to the nature of business and risk exposures, and the scope of work includes financial and operational reviews.

The three-year audit plan is further divided into three annual audit plans. Every year, the Internal Audit Department reviews the upcoming annual audit plan and makes adjustments to it where appropriate. The three-year audit plan and the annual audit plans, with subsequent adjustments where appropriate, are reviewed and agreed by the Audit Committee. In addition to the agreed schedule of work, the Internal Audit Department conducts other review and investigative work as may be required. The Audit Committee receives summary reports from the Internal Audit Department periodically while the results of internal audit reviews and responses to the recommended corrective actions are also reported to the Executive Directors and senior management. The Internal Audit Department is also responsible for following up the corrective actions to ensure that satisfactory controls are maintained.

As stated in the section on "Audit Committee Report", the Audit Committee is satisfied that the risk management and internal control system of the Group for FY2023 and up to the date of this Annual Report continued to be effective and adequate. The Company also concurs with the view of the Audit Committee and considers its risk management and internal control systems are effective and adequate during FY2023.

#### Internal Control – Other Control and Management

### Code of Conduct

The Company's policy on Code of Conduct is also an important part of the Group's internal control process. The Code of Conduct is a written statement of the core standards of behavior expected by the Group. It includes provisions addressing a wide range of areas and it covers among others, improper business courtesies, conflicts of interest, handling of confidential and proprietary information and intellectual property, relationships with suppliers, contractors, customers, and business partners, competing with integrity, international trade and interacting with government, environmental protection, occupational health and safety, respect of labour and human rights, and equal opportunities.

Employees are required to strictly follow the Code of Conduct to ensure the Group operates to the highest standards of business behaviour and ethics in our dealings with customers, business partners, shareholders, employees, and the business community. The policy is reinforced and monitored by an annual confirmation of compliance in writing. The Code of Conduct was last updated in April 2022.

#### Whistleblowing Policy

The Group maintains a Whistleblowing Policy to facilitate the raising of matters of serious concern by employees and those who deal with the Company (e.g. customers and suppliers), in confidence and anonymity, without the fear of recrimination. Procedures are established for employees to report complaints and suspected internal malpractices directly to the Group Chief Compliance Officer, who will review the complaints and determine the appropriate mode of investigation and subsequent corrective action. Recommendations on improvements are communicated to the respective department's senior management for implementation.

## Anti-Corruption Policy

The Group is committed to achieving the highest standards of business conduct and has zero tolerance for corruption and related malpractice. The Anti-Corruption Policy forms an integral part of the Group's corporate governance framework. Other relevant policies of the framework, including the Code of Conduct, the Policy on Gifts, Entertainment and Gratuities, and the Whistleblowing Policy, outline the Group's expectations and requirements of business ethics, as well as the investigation and reporting mechanism of suspected corruption practices.

The Anti-Corruption Policy sets out the specific behavioural guidelines that VTech personnel and business partners must follow to combat corruption. It demonstrates VTech's commitment to the practice of ethical business conduct and the compliance of the anti-corruption laws and regulations that apply to its local and foreign operations. Every employee, officer and members of the Board must act with the utmost integrity, defined not only by the applicable laws and regulations, but also by the determination to do the right thing in all circumstances.

Regular training for employees to enhance their understanding of the policy requirements is organised. The annual declaration made by our staff under the Code of Conduct includes their confirmation of the compliance with the policy. The Anti-Corruption Policy is reviewed and updated periodically to align with the applicable laws and regulations as well as the industry best practice. ## **Risk Register**

As part of its process used to review the effectiveness of the risk management and internal control systems and to resolve material internal control defects (if any), the Company maintains the Risk Register to record the major and identifiable risks in the critical functions in the operation of the Company. The Risk Register is being reviewed by the Risk Management and Sustainability Committee twice a year. At management level, department representatives of each key business unit/function maintain a risk register documenting the key risks and the response measures of the relevant risk. To facilitate the review of the Risk Register by the Risk Management and Sustainability Committee, the Internal Audit Department will review the operation of the risk management framework, including the effectiveness of reporting to the highest levels, and the continuing operation of appropriate risk responses.

## Liability Insurance for the Directors

The Company purchases annually the Directors' and officers' liability insurance for members of the Board to provide protection against claims arising from the lawful discharge of duties by the Directors.

The general meetings of the Company provide an opportunity for communication between shareholders and the Board. An AGM shall be held in each year at the time and place determined by the Board.

# Procedure for shareholders to convene special general meeting

Under the Company's Bye-laws, in addition to regular AGMs, the Board, on the requisition of shareholders of the Company holding not less than 10% of the paid-up capital of the Company, may convene a special general meeting to address specific issues of the Company within 21 days from the date of deposit of written notice to the registered office of the Company. The requisition(s) must state the purposes of the meeting, and must be signed by the requisitionist(s).

#### Procedure for shareholders to propose resolution at AGM

Shareholders holding not less than 5% of the total voting rights of all the shareholders or not less than 100 shareholders may propose any resolutions at the AGM and circulate to other shareholders written statement with respect to the matter to be dealt with at the AGM by sending a written notice of their proposals to the Company Secretary at the Company's principal office at the address of 23rd Floor, Tai Ping Industrial Building, Block 1, 57 Ting Kok Road, Tai Po, New Territories, Hong Kong or by email to investor\_relations@vtech.com.

## AGM

VTech's AGM is held in the month of July each year. The AGM, which is attended by the Directors, senior management, external auditor and lawyer, is an important event for the Board to communicate with its shareholders on the Group's business performance and affairs every year.

In order to ensure that the Group's shareholders have sufficient time to review the AGM notices, annual report and financial statements, all the AGM related documents are dispatched to the shareholders more than 20 clear business days before the AGM.

VTech also conducts all voting at the AGM by poll with whole process scrutinised by the Company's share registrar in attendance of the AGM. Procedures for conducting the poll are explained at the AGM prior to taking the poll. Poll results are announced and posted on the websites of the Stock Exchange and the Company at www.vtech.com.

VTech held its 2022 AGM at Marco Polo Hongkong Hotel. The matters resolved at the 2022 AGM were set out as follows:

- Receipt and consideration of the audited consolidated financial statements and the reports of Directors and the auditor for the year ended 31 March 2022;
- Consideration and declaration of a final dividend in respect of the year ended 31 March 2022;
- Re-election of Dr. Allan WONG Chi Yun as Executive Director;
- Re-election of Dr. Patrick WANG Shui Chung as Independent Non-executive Director;
- Re-election of Mr. WONG Kai Man as Independent Nonexecutive Director;

- Fixing the Directors' fee (including the additional fee payable to chairman and members of the Audit Committee, the Nomination Committee and the Remuneration Committee) for FY2023;
- Re-appointment of KPMG as auditor and authorization given to the Board of Directors to fix its remuneration;
- Granting of a general mandate to repurchase shares representing up to 10% of the issued share capital of the Company as at the date of the 2022 AGM; and
- Granting of a general mandate to allot, issue and deal with additional shares representing up to 10% of the issued share capital of the Company at the date of the 2022 AGM, and the discount for any shares to be issued not to be more than 10% to the benchmarked price.

VTech's 2022 AGM was held successfully in spite of the COVID-19 pandemic in Hong Kong. The following special arrangements and precautionary measures to protect the health and safety of all attendees were also put in place:

- Compulsory temperature screening/checks;
- Mandatory wearing of surgical face mask;
- Scanning of the "Leave Home Safe" venue and vaccination record QR codes as well as complying with the requirements of the Vaccine Pass Direction;
- Maintaining an appropriate social distancing between seats; and
- No provision of gifts, refreshments or drinks.

In light of the uncertain development of the COVID-19 situation, instead of attending the 2022 AGM in person, shareholders were encouraged to exercise their rights and indicate how they would like the proxy to vote on their behalves by submitting a form of proxy to appoint the Chairman of the 2022 AGM as their proxy for voting.

As for the AGM in 2023, which is scheduled to be held on 19 July 2023 (the "2023 AGM"), in order to ensure the health and safety of the shareholders attending the meeting, VTech reminds the shareholders to follow any the prevailing guidelines published by the Government of the Hong Kong Special Administrative Region and regulatory authorities and encourages the shareholder to appoint the Chairman of the 2023 AGM as their proxy and submit their proxy form as early as possible. Details of the measures will be announced in due course.

## Changes in Constitutional Documents

There was no change in the Company's constitutional documents during FY2023.

At the 2023 AGM, proposed amendments will be made to the existing Bye-laws of the Company for the purpose of bringing the Bye-laws in line with the Core Shareholder Protection Standards set out in Appendix 3 to the Listing Rules and providing for an electronic or a hybrid meeting where the shareholders of the Company may attend the shareholders meetings of the Company by electronic means in addition to a traditional physical meeting where the shareholders of the Company can only attend physically. Appropriate housekeeping amendments are also proposed to bring the Bye-Laws of the Company in line with the major amendments proposed.

The proposed amendments to the existing Bye-laws of the Company and the adoption of the new Bye-laws will be subject to the approval of the shareholders of the Company by way of a special resolution at the 2023 AGM.

Shareholders Communication Policy

The Company has established a Shareholders Communication Policy to set out the procedures for providing shareholders and the investment community with ready, equal and timely access to balanced and understandable information about the Company. This is to enable shareholders to exercise their rights in an informed manner, and to allow shareholders and the investment community to engage actively with the Company.

Shareholders and the investment community may at any time make a request for publicly available Company information or communicate their view to the Company by email to investor\_relations@vtech.com, by post addressed to the Company's principal office, via the contact form on the Company's website or through the Company's share registrar.

The Company reviews the implementation and effectiveness of the Shareholders Communication Policy annually. The most recent review was conducted in May 2023 and the effectiveness of the policy was confirmed, as multiple channels of communication and engagement were in place and adopted.

## Dividend Policy

The Company has established a Dividend Policy to set out the guidelines for the Board to determine (i) whether dividends are to be declared and paid; and (ii) the level of the dividend to be paid to the shareholders. It is the policy to allow the shareholders to participate in the Company's profits whilst to retain adequate reserves for future growth.

Normally, the Company pays dividends twice a year, which are the interim dividend and final dividend. In determining and recommending the frequency, amount and form of any dividends in any financial year/period, the Board shall consider the following factors:

- actual and expected financial performance of the Group;
- global economic conditions and other factors that may have an impact on the business or financial performance of the Group;
- Group's business strategies, current and future operations, liquidity position and capital requirements, including future cash commitments and investment needs to sustain the long-term growth aspect of the business;
- any restrictions on payment of dividends in the Company's Bye-laws or may be imposed by the Group's lenders; and
- any other factors that the Board deems appropriate.

## **Roles and Responsibilities**

The Audit Committee has been established to assist the Board in fulfilling its overseeing responsibilities for financial reporting, risk management, corporate governance functions, and evaluation of internal control systems and internal auditing processes. It also ensures that the Group complies with all applicable laws and regulations.

The Audit Committee is also responsible for overseeing the effectiveness of formal procedures for employees to raise any matters of serious concerns and is required to review any reports made by the Internal Audit Department in this regard.

Furthermore, the Audit Committee acts as the key representative body for overseeing the Group's relationship with the external auditor, reviews and monitors the external auditor's independence and the effectiveness of the audit process in accordance with applicable standards.

Mr. WONG Kai Man, as the chairman of the Audit Committee, has the appropriate financial management expertise as required under the Listing Rules. The Audit Committee has held two meetings during FY2023. In addition to the Audit Committee members, the meetings were attended by the Group Chief Executive Officer, the Company Secretary and Head of Internal Audit, the Group Chief Financial Officer and the external auditor.

On the date of this Annual Report, the Audit Committee reviewed the Group's audited consolidated financial statements and reports for FY2023 in conjunction with the Company's external auditor and senior management before recommending them to the Board for consideration and approval. The financial results of the Group for FY2023 have been reviewed with no disagreement by the Audit Committee. The Audit Committee has also reviewed and approved the Policy on Provision of Non-Assurance Services by Auditor, the key ESG issues and the related risks and strategies, and the 2023 Sustainability Report.

In addition to the above, the Audit Committee assisted the Board in meeting its responsibilities for maintaining an effective system of internal control and risk management during FY2023. It reviewed the process by which the Group evaluates its control environment and risk assessment procedures, and the way in which business and control risks are managed twice a year.

It should be noted that a system of internal control and risk management, no matter how well it is designed and operated, can only provide reasonable but not absolute assurance that the objectives of the system of internal control, such as safeguarding assets from inappropriate use, material transactions being executed according to the Group's policies or ensuring compliance with regulations, are met. As a result, it should not be expected that a system of internal control will prevent or detect all errors and frauds.

Based on the information received from the management (including the Risk Management and Sustainability Committee and Data Security Governance Board), the external auditor and the Internal Audit Department, the Audit Committee is satisfied that the overall financial and operational controls, risk management and internal control system, and the internal audit function of the Group for FY2023 and up to the date of this Annual Report continued to be effective and adequate.

The Audit Committee has also been given the responsibility to oversee the effectiveness of formal procedures for employees to raise any matters of serious concerns and is required to review any reports made by the Internal Audit Department in this regard.

## **Internal Audit**

The Audit Committee reviews the report prepared by the Head of Internal Audit. The report covered implementation status of the annual audit plan, whistleblowing complaints received and the corresponding status of investigation, as well as the effectiveness and adequacy of the Group's overall financial and operational control. The annual audit plan of the upcoming financial year was presented to the Audit Committee for review and approval.

#### **External Auditor**

The Audit Committee meets with the external auditor to review the nature, scope and results of their audit with senior management. The external audit engagement partner is subject to periodical rotation of not more than seven years.

The Nomination Committee is chaired by Dr. William FUNG Kwok Lun with Professor KO Ping Keung, Dr. Patrick WANG Shui Chung, Mr. WONG Kai Man and Dr. Allan WONG Chi Yun as members. The majority of the members of the Nomination Committee are Independent Non-executive Directors.

## **Roles and Responsibilities**

The Nomination Committee is responsible for reviewing the structure, size and diversity of the Board and monitoring the implementation of the Board Diversity Policy and Nomination Policy for appointment to the Board as appropriate.

The Nomination Committee is also responsible for assessing the independence of the Independent Nonexecutive Directors, including the annual confirmation of the independence of the Independent non-executive Director, the assessment on the ability to devote sufficient time to the Board and the length of service of the proposed Independent Non-executive Director according to the requirements of the Listing Rules and making recommendations to the Board on the appointment or reappointment of the Directors and succession planning for the Directors.

### Nomination Policy

The Nomination Policy sets out the selection criteria and procedures for the Nomination Committee to select and recommend suitable candidates for directorship. These criteria and procedures are designed to assist and enable the Board to have all the relevant information and necessary recommendations for determining the suitability of a candidate for appointment so that the Board shall continue to have a balance of skills, experience and diversity of perspectives appropriate to the requirements and ongoing and future development of the Company's business.

The Nomination Committee shall consider a variety of factors in assessing the suitability of a proposed candidate for directorship, including but not limited to the following selection criteria:

 Board Diversity Policy that takes into consideration a number of factors including gender, age, cultural and educational background, skills, knowledge, industry and professional experience, business perspectives and the legitimate interests of the Company's principal shareholders;

- accomplishment and experience appropriate to the requirements of the Company's business;
- commitment in respect of sufficient time, interest and attention to the Company's business; and
- compliance with the criteria of independence under the Listing Rules for the appointment of Independent Nonexecutive Director.

If the Board recognises the need to appoint a new Director subject to the provisions in the Company's Bye-laws, the Nomination Committee would generally adopt the following procedures:

- the Nomination Committee, with or without assistance from external agencies, will identify candidates in accordance with the selection criteria and factors including such other factors as may be considered by the Nomination Committee from time to time;
- the Nomination Committee will consider and evaluate the merits of each identified candidates;
- the Nomination Committee will recommend the candidate(s) considered most suitable for the Board's consideration and if the Board deems fit, appointment as a Director in accordance with Company's Bye-laws;
- the Board will decide on the appointment based upon the recommendation of the Nomination Committee; and
- the Company Secretary shall ensure all disclosure obligations under the Listing Rules regarding the appointment are duly complied.

In considering the re-appointment of any existing member(s) of the Board, the Nomination Committee shall review the retiring Director's overall contribution to the Company as well as the selection criteria set out in the Nomination Policy and the Board Diversity Policy. The Nomination Committee will then make recommendations to the Board for its consideration, with the Board determining whether to recommend the proposed Directors for re-election at the annual general meeting.

Candidates for appointment as Directors may also be sourced internally or externally through various channels such as using the services of specialist executive search firms. The aim is to appoint individuals of the highest calibre in their area of expertise and experience.

During FY2023, the Nomination Committee, taking into consideration the gender diversity agenda and the selection criteria above, recommended to the Board to consider the appointment of a new female Independent Non-executive Director, Professor GAN Jie. Following the consideration and recommendation of the Nomination Committee, the Board agreed to appoint Professor GAN Jie as an Independent Nonexecutive Director and a member of the Audit Committee of the Company. Announcement of the appointment was made on 24 March 2023.

Remuneration Committee reviews the emoluments of Executive Directors and senior management based on skills, knowledge and performance, together with reference to the salaries paid by comparable companies, time commitment and responsibilities, the prevailing market conditions, the financial performance of the Company, employment conditions elsewhere in the Group, and the desirability of performance-based remuneration linking rewards to corporate and individual performance. In addition, the Remuneration Committee is also responsible for reviewing and approving matters relating to the share schemes under the Listing Rules.

- benchmarking of the remuneration package of Executive Directors and senior management with reference to companies with comparable business and size;

- proposed annual salaries increment and the performance-related remuneration packages for Executive Directors and senior management, including granting of share awards under the share purchase scheme subject to achievement of certain targets for FY2023. The management bonus and long-term incentive awards for Executive Directors and senior management, which are linked to the corporate and individual performance, and the financial performance of the business in which they are responsible, have been reviewed and approved by the Remuneration Committee; and
- revised Remuneration Committee charter.

The Remuneration Committee also reviewed and approved the grant of awarded shares to the management staff under the existing share purchase scheme. Under the existing share purchase scheme, there is no specific requirement on the length of the vesting period (save for the French Subplan) or performance target nor clawback mechanism. The Remuneration Committee is of the view that a vesting period shorter than 12 months for the awards of the awarded shares granted to the management staff is appropriate considering that the grant of the awarded shares to the management staff serve as a recognition of their past contribution to the Group or outstanding performance in the preceding financial year and incentivise them to continuously contribute to the operation, development and long-term growth of the Group. The Remuneration Committee also believe that without additional performance target and clawback mechanism, the grant of the awarded shares could retain such management staff to continue serving the Group whilst at the same time providing these employees incentive in achieving the goals of the Group, which is in line with the purpose of the existing share purchase scheme and aligns the interest of the management staff with that of the Company and its shareholders

On the date of the Annual Report, the Remuneration Committee reviewed and approved the revised share schemes (including the share option scheme and share purchase scheme) before recommending them to the Board to consider the amendments to the 2021 share option scheme and existing share purchase scheme to bring them in line with the amendments to Chapter 17 of the Listing Rules, which came into effect on 1 January 2023 and subject to the approval by the shareholders of the Company.

## **Directors' Fees**

The Board has adopted a practice to review the fees for the Directors, in particular the remuneration of the Independent Non-executive Directors, every five years and ensure that they are remunerated on a fair and reasonable basis. It comprises all Executive Directors, an Independent Non-executive Director, the TEL President, the Group Chief Financial Officer, and the Company Secretary and Head of Internal Audit.

### **Roles and Responsibilities**

The Risk Management and Sustainability Committee is responsible for monitoring and reviewing the risk management and internal control systems, as well as the sustainability strategies, performance and activities of the Group on a regular basis. It also reports to the Audit Committee of any significant findings twice a year.



The Risk Management and Sustainability Committee has also developed an internal risk management structure at both management and operational levels, which has clearly defined the roles and responsibilities in managing potential risks in the respective areas, and set up procedures for execution of the Group's Business Continuity Plan in the event of disruptions. The Business Continuity Management ("BCM") programme not only helps identify and mitigate the Group's potential operational risks, but also increases its resilience capability to resume operations in an effective and timely manner, thus ensuring that it always has a smooth business operation.

The Risk Management and Sustainability Committee is also delegated with the authority from the Board to provide vision and strategic direction for the Group's sustainability activities, review its sustainability strategies and improvement activities, assess how the policies are implemented in achieving the sustainability goals and targets, and monitor the performance progress twice a year.

## Highlights of the Committee's Work in FY2023 (Continued)

The Risk Management and Sustainability Committee ensures that any new and emerging risks are promptly identified, evaluated and appropriate actions are taken by the management. This requires the active and frequent participation by the process owner of each function in identifying risks affecting its business and implementing measures to reduce such risks, as well as the active monitoring on the progress of the improvement in internal control procedures.

## Data Security Governance Board

The Data Security Governance Board was established with defined terms of reference reporting to the Risk Management and Sustainability Committee. It is chaired by the Group Chief Executive Officer and comprises the Group President, the CMS Chief Executive Officer, the TEL President, the Group Chief Financial Officer, the Company Secretary and Head of Internal Audit, and the Group Chief Information Officer.

The Data Security Governance Board is responsible for the decision-making, implementation, enforcement, oversight and periodic review of the Data Security Policy and practices, as well as the cybersecurity risks and mitigation measures of the Group. It also ensures that the Group's data security practices are compliant with international and local laws and regulations, including but not limited to, the applicable privacy ordinances and data protection regulations in the respective countries such as the General Data Protection Regulation in Europe.

The Data Security Governance Board has reviewed and monitored the implementation and execution of the Data Security Policy and practices of the Group for the compliance with the latest privacy ordinances and data protection regulations in the respective countries during FY2023. It has also reviewed the implementation progress of the additional preventive measures, technologies enhancement and staff trainings for the mitigating the Group's exposure to cybersecurity risks. In addition, the Data Security Governance Board has reviewed and monitored the remedial actions of the identified security related issues which have been brought to its attention. During FY2023 and up to the date of this Annual Report, the Risk Management and Sustainability Committee has reviewed and approved the meeting minutes of the Data Security Governance Board.

## **Overall Risks Assessment**

Based on the risk assessments prepared by process owner of each function and the respective management teams, the Risk Management and Sustainability Committee considered that for FY2023:

- Ongoing process is in place for identifying, evaluating and monitoring the major risks faced by the Group and functioning effectively; and
- Risk mitigation measures have been developed to ensure that the major emerging and existing risks identified and reported to the Risk Management and Sustainability Committee are managed effectively to mitigate the risks of disruption on the Group's business and operations.

# Product Responsibilities and Value Chain Management

VTech's culture of innovation, which supports and encourages creative thinking and sharing of new ideas in the workplace, not only facilitates its employees to design and develop innovative and high quality products for the wellbeing of people and benefits of society, but also upholds the highest international and local quality and safety standards. VTech's management approach continues to focus on two key management principles – "Design for Excellence" and "Design for People". It is also dedicated to incorporating sustainability concepts into the design of products to make them more eco-friendly and sustainable.

### **Design for Excellence**

VTech's designers and engineers are required to follow the requirements on the Life Cycle Assessment checklist to select more eco-friendly product and packaging materials, reduce the use of materials and energy, maximise the use of reusable items and avoid disposal of recyclable materials to landfill during the product development stage.

VTech continues to improve its manufacturing process to make it more sustainable. For example, in order to minimise the environmental impact of the colouring process, the Group continues to replace solvent-based paint with waterborne paint in its products and packaging, and adopted the over-molding and inkjet printing technologies in the manufacturing process. In FY2023, waterborne paint was used in about 90% of ELPs and 87% of TEL products. As for packaging, waterborne paint was used in about 99% of ELP packaging and about 82% of TEL product packaging. VTech has also been working on extending the product life cycle from cradle-to-grave to cradle-to-cradle, through the increasing use of sustainable materials for its products and packaging, as well as engaging in post-consumer recycling programmes for its products and packaging.



Inkjet Printing Technology

With its sustainability goal to replace fossil-based virgin plastics with sustainable materials such as recycled, reclaimed, recyclable, plant-based plastics, or Forest Stewardship Council®-certified wood, VTech continues to use sustainable materials in its products and packaging with target towards a circular economy. In FY2023, VTech expanded its range of eco-friendly ELPs made from sustainable materials. These included the Snuggle Sounds

Whale and Bundle of Fun Zebra Gift Set with fabrics sourced from recycled polyethylene terephthalate (PET) bottles, and the Make & Spin Bouquet<sup>™</sup> and Sorting Fun Apple made from reclaimed plastics. VTech also launched more wooden toys with materials sourced from responsibly managed forests certified by the Forest Stewardship Council<sup>®</sup> (FSC), which included the LeapFrog<sup>®</sup> ABCs & Activities Wooden Table and LeapFrog<sup>®</sup> Touch & Learn Wooden Activity Cube.

With regard to TEL products, VTech introduced a series of hotel phones made from recycled PET bottles with antibacteria technology.

VTech has also continued to develop Digital Enhanced Cordless Telecommunications cordless phones with Blue Angel eco-label, and upgraded the power adaptor to the level VI standard with Energy Star eco-label.



As for the packaging of ELPs, currently 95% of the packaging materials was recyclable, of which about 85% was made from recycled materials. VTech has also eliminated blister in 99% of the ELPs packaging, and continued to replace fossil-based blister packaging with sustainable alternative such as biobased or recycled PET in new ELPs packaging. In addition, it has eliminated plastic packaging in over 60% of the baby monitor products.

In order to support circular economy initiatives for recycling of its products and packaging in a responsible way, VTech has partnered with various leading international recycling companies in its major markets. For post-consumer products recycling, VTech has engaged with TerraCycle® in the US and Electronic Products Recycling Association in Canada. It has extended the post-consumer product recycling in the US for telecommunication products by partnering with Electronic Scrap Recycling (ESR). It has also followed the Waste Electrical and Electronic Equipment Directive in Europe by adding product recycling labels on the product packaging. These recycling programmes provide an easy way for consumers to recycle VTech's ELPs in the respective countries.

As for post-consumer packaging recycling programmes, VTech has also engaged in various recycling organisations in the US, the UK, Australia and New Zealand. Packaging recycling labels such as How2Recycle® and "OPRL" the On-Pack Recycling label have been placed on the product packaging of its ELPs for consumers' easy reference. VTech will continue to explore opportunities to extend these postconsumer products and packaging recycling programmes to other major markets.

VTech is also committed to designing and manufacturing products that meet the highest international and local health and safety standards. All the manufacturing facilities are certified with Quality Management System: ISO 9001. It has implemented a stringent quality control system, from incoming materials inspection, in-process quality audit, finished goods quality assessment, to after-sales management to ensure that its products meet the required specifications and are free from defects at the time of delivery. As product safety is always its number one priority, VTech continues to strengthen its quality assurance and management programmes throughout the whole product life cycle from the early stage of product design, to the aftersales services and warranties.

### Product Responsibilities and Value Chain Management

### **Design for People**

As a global leader in the electronic learning products, VTech has launched various new learning toy products to inspire the creativity



to inspire the creativity World Map™ of children. These included the LeapFrog® Magic Adventures

Microscope<sup>™</sup>, an interactive learning product for kids to learn about vocabularies and fun knowledge through BBC videos, images, quizzes and adventure games; and LeapFrog<sup>®</sup> Touch & Learn World Map<sup>™</sup> a world map featuring interactive touch points that enables to learn the world's continents, natural wonders, and animals.

As for baby care products, VTech has launched baby monitors under LeapFrog brand with field range of up to 2,500 feet and touch screen features, which provides parents with an enhanced remote monitoring experience. VTech has also upgraded the screen resolution from 720p to 1080p with premier colour and viewing angles, which allows parents to view their babies with clearer images on the display.

VTech is committed to delivering high quality products to customers while upholding the highest legal and ethical standards for its marketing activities to protect the rights of its consumers. It has a Responsible Marketing and Labelling Policy in place to ensure that the Group adheres to the applicable regulatory requirements on responsible marketing for the provision and communication of accurate and reliable marketing information about its products and services to its customers, particularly children.

### **Sustainable Supply Chain**

A sustainable supply chain management is crucial for the Group's sustainable operations. VTech has a well-established "Supply Chain Management System" to monitor the quality and sustainability performance of its suppliers. In order to mitigate environmental and social risks throughout the supply chain, VTech has established a Supplier Code of Conduct, Conflict Minerals Policy, and Modern Slavery and Transparency in Supply Chains Statement according to international and industry standards including the United Nations Global Compact and the Responsible Business Alliance (collectively VTech Supplier Policy). All suppliers are required to comply with the VTech supplier CSR requirements in relation to human rights, labour practices, health and safety, business ethics, minerals sourcing as well as environmental protection. VTech actively monitors its suppliers to ensure they do not procure products that contain 3TG, cobalt and mica originated from CAHRAs, and requires suppliers to perform due diligence which aligns with the OECD Due Diligence Guidance and the Conflict Minerals Reporting Template (CMRT).

VTech also collaborates with its suppliers to provide a safe, inclusive and sustainable workplace for their employees, and promote ethical sourcing practices with suppliers' commitment to VTech Supplier Code of Conduct. In FY2023, VTech continued to conduct supplier engagement workshops for its suppliers virtually. It also provided suppliers with hands-on training and guidance for suppliers to achieve continuous improvement in their sustainability performance.

### Environment

As an environmentally conscious and sustainable company, VTech is committed to protecting the environment and mitigating the impacts of climate change with target towards a circular economy. Its culture of innovation also facilitates VTech to strengthen its operational excellence with innovative solutions to continuously improve its productivity, and incorporate sustainability concepts in the business operations. It recognises that climate change could create uncertainties in its business development. In the 5-year Sustainability Plan 2025, VTech has developed "Climate Change Strategy" to assess how climate change could affect its business operations, identified the associated risks and opportunities, and developed sustainability initiatives to address them in the coming five years.

In response to climate change, VTech has been assessing and enhancing the monitoring measures of its climaterelated risks and environmental impacts while upholding the TCFD recommendations since FY2020. Climate scenarios were identified and incorporated into the risk assessment process, and the impacts of physical and transition risks of climate change on business were evaluated under different timeframes. The assessment results help VTech to build stronger resilience against the climate-related risks with regard to their impact, and seize the opportunities of lowcarbon future in its business development.



Application of Solar Technology

Two key principles – "produce for quality" and "produce for efficiency" – are the main drivers for the manufacturing process improvement. VTech has been implementing the low cost automation and lean manufacturing programmes to maximise its resources utilisation and improve the productivity without compromising the quality of its products, while aiming to reduce the potential environmental impacts throughout the manufacturing process. The major environmental impacts from VTech's operations relate to energy and water consumption, waste production and logistics. VTech has incorporated the 3Rs (Reduce, Reuse, and Recycle) principle into its manufacturing process, and established energy and resources management system to better utilise the resources in its manufacturing process, aiming to reduce the energy and water consumption, minimise the waste production and improve the reuse rate of resources.

VTech aims to operate its manufacturing processes and facilities in a manner that minimises the impacts to the environment, and ensure that its operations are compliant with all the relevant environmental, legal and regulatory requirements. By implementing the high performance production chain and lean manufacturing programmes, it has improved the resources efficiency and productivity while maintaining the green manufacturing practice. In addition, VTech has increased its use of renewable energy by accelerating the installation of solar panels at its manufacturing sites in FY2023, which covered around 7,120 square metres of its production buildings. Four of VTech's overseas offices have also switched to renewable energy providers for their electricity consumption. In FY2023, VTech procured and generated about 1,160 MWh of renewable electricity globally. More solar energy projects are planned for the manufacturing sites in FY2024.

VTech strives to reduce the Scope 3 Greenhouse Gas (GHG) emissions through the adoption of a green logistic management approach, and choosing the most eco-friendly transportation mode for delivering the incoming materials from suppliers and outgoing products to the customers. These included the relocations of the distribution centres in the US, Canada, Australia and Spain to enhance the logistic efficiency. In FY2023, VTech has planned to set up a new warehouse in France to reduce both the time and distance for delivering products to its French customers.

VTech has also continuously worked with government bodies to minimise the environmental impact of the production facilities. The TEL products manufacturing site has been certified as the "Hong Kong – Guangdong Cleaner Production Excellent Partners" by the Hong Kong Productivity Council and Guangdong Provincial Government in recognition of the positive contribution to improving the air quality and local environment in FY2023 for the eight consecutive years. It has also been recognised as the "Dongguan Environmentally Friendly Enterprise" by the Dongguan, Guangdong Province Environmental Protection Bureau in mainland China in FY2023 for the eight years.

### Environment

Moreover, the VOCs purification system was recognised as "Demonstration Project" under the Cleaner Production Partnership Programme of Hong Kong Productivity Council in FY2019. All the existing manufacturing sites of the TEL products, ELPs and CMS are certified with the ISO 14001 standard for environmental management, demonstrating that VTech is committed to continuous improvement on environmental protection.

In prior years, VTech had installed a rainwater harvesting system, wastewater treatment system and grey water harvesting system for greenery, cleaning and dormitory consumption at the operation sites. To further reduce freshwater consumption, it has extended the wastewater reuse to the manufacturing processes. The Company has also upgraded the water infrastructure to improve the operational efficiency. In addition, VTech has continued to implement various water saving campaigns at its dormitories and manufacturing sites. With the extensive effort in carrying out different water saving programmes, VTech managed to reduce the total water consumption per production output by 24% compared with FY2020.

As for the waste management in the manufacturing sites, VTech aims to minimise avoidable waste and increase the rate of recycling. In FY2023, we installed automatic rice serving machines at the canteen with different serving amount to reduce food waste. VTech has also worked closely with its suppliers by returning plastic recyclables to suppliers for reuse. With such waste reduction and recycling projects in place, VTech achieved recycling rate of 81% in FY2023. VTech is committed to minimising the potential environmental impacts from its operations with the following principles:

- Comply with all relevant environmental, legal and other statutory requirements
- Maintain an Environmental Management System in line
   with the requirements of ISO 14001
- Quantify and monitor the significant environmental impacts of our activities, products and services and set specific targets for improvement where appropriate, and review these annually
- Integrate environmental objectives into our business decisions in a cost effective manner
- Require all staff to address environmental responsibilities within normal operating procedures
- Enhance awareness of environmental and resource efficiency issues amongst our customers, suppliers, staff and stakeholders through improvement projects and programmes in the respective areas

In order to meet the above requirements in a sustainable manner, VTech has functional teams comprising individuals from different product lines and departments across the organisation. The environmental policy is reviewed annually to ensure that it is relevant and up to date.



Lean Manufacturing and Low Cost Automation

## Our People

VTech aims to provide a safe, inclusive and motivating workplace for its employees. It also promote a culture of integrity with human resources management policies in place to foster a caring atmosphere with mutual respect in the workplace. VTech cares for its employees and recognises that having good staff relations and a motivated workforce play a vital role in the Company's efficient operations. All the existing VTech assembly and plastic factories in mainland China are certified with the Occupational Health and Safety Management Systems (ISO 45001). TEL and CMS assembly factories in mainland China are also certified with Social Accountability (SA 8000) certification and ELPs with ICTI Ethical Toy Program compliance certification. These external verified certifications demonstrate the compliance with local laws and high guality working conditions.

VTech's human resources management policy builds on four key values – "Communication and Staff Relations", "Advancement in Careers", "Respect of Labour and Human Rights", and "Environment for Our People" (CARE). To ensure the effectiveness of the workplace management system, VTech conducts employee satisfaction survey regularly and has cross functional teams and committees at different manufacturing sites, to determine goals and targets, discuss new projects, and review project progress on improvement of workplace and employees-related issues based on the feedback from the employees.

VTech is dedicated to providing a diverse, equitable and inclusive working environment for its employees. In addition to the gender diversity in its Board of Directors, VTech's global workforce consisted of 41% women, with 26% of management positions held by women.

In respect of human rights, VTech has a Human Rights Policy with risk management programme in place for the Group to protect and safeguard the human rights of its stakeholders including its employees, customers, suppliers and the local communities in which it operates. It supports the internationally-recognised human rights principles laid out in the International Bills of Human Rights and the International Labour Organisation's Declaration on Fundamental Principles and Rights at Work. Ongoing due diligence process to identify, assess, prevent, and mitigate potential human rights risks is also included in the risk management system. This Human Rights Policy, together with the Group's code of conduct for its employees and its suppliers, facilitate VTech to foster a culture of integrity in the workplace for its employees, and engage in ethical sourcing practices with its suppliers across the supply chain.

### Our People

In addition, VTech has clearly defined human resources management policies and a transparent performance evaluation system to promote an inclusive working environment with equal opportunity for all employees. The Company has procedures in place to ensure that its policies are properly implemented throughout the Company. Any issues or enquiries raised by the employees through different communication channels will be handled and investigated by the Company with care and in a confidential manner.

VTech recognises open communications is an important element in achieving effective workplace management system. The Company encourages employees to voice out their opinions through various communication channels at all levels throughout the Company. All information, opinions and suggestions gathered from employees are followed up by the employee relations team. VTech also believes staff relationship could be further strengthened by their participations in different kinds of staff activities. It continues to organise various activities including leisure, social events and outing for the employees.

VTech encourages its employees to develop and advance their careers in the Company. It also actively promotes continuous learning initiatives and a culture of integrity with a wide range of training programmes for the employees to instill and reinforce the Group's values of acting lawfully, ethically and responsibly. With the effort in promoting continuous learning, the average training hours per employee is about 72 hours. Protecting the health and safety of employees is always the Company's top priority. In order to ensure that a safe working environment is provided at all the workplaces worldwide, VTech has continued to implement various precautionary measures in its offices and factories following the local government and World Health Organisation guidelines. It also has Employee Health and Safety (EHS) teams at all the manufacturing sites to conduct the regular health and safety audit, and provide different training programmes for the employees. EHS assessment is conducted for newly purchased equipment to identify and mitigate safety hazards prior to work. Safety trainings and campaigns are regularly promoted to strengthen the workers' involvement in safety management. With the continuous activities and efforts focusing on workplace safety, the health and safety training hours per employee continued to increase compared with the last financial year, and it did not have any work-related fatality case.

The majority of employees in the mainland China manufacturing facilities are from different provinces of the country. VTech recognises that to make them feel at home, and have a sense of belonging while they are living in the dormitories are very important. The Company has continuously upgraded the recreational facilities and dormitories at the manufacturing sites. For examples, in FY2023, dormitories in the ELP and CMS factories were refurbished to continuously improve the living environment. The recreational facilities in CMS factory were also upgraded by setting up table tennis courts, snooker, gymnasium and dancing rooms for workers to enjoy the facilities in leisure time.

## Society

As a responsible corporate citizen, VTech promotes a culture of accountability for the communities in which it operates in various ways, focusing on helping people in need, collaborating with local charities to support the local charitable events, providing training opportunities for young people, nourishing an innovative environment and developing a healthy and green community.

Since the establishment of VTech's voluntary teams in different manufacturing sites and global offices, the Company has participated in various voluntary events, and created a strong social network to assist and support the people in need. It also encourages the employees and their families to participate in the volunteering activities, bringing positive impact to the people and the society. In FY2023, VTech had recruited 2,540 volunteers and contributed over 20,400 volunteering hours for the communities.

VTech also uses its expertise and resources to support the communities in which it operates. It has collaborated with Save the Children, an international charitable organisation supporting marginalised and vulnerable children, to organise fundraising and toys donation events across multiple countries for three consecutive years. These included

a worldwide toy donation programme with over 3,600 electronic learning toys donated by VTech. It also made donations through the participation in "A Meal for Meals", "Master Chef for Hunger" and "Christmas Jumper Day" campaigns. In addition, VTech has been donating US\$1 to Save the Children for every baby monitor and toy sold through our online shops in Canada and Hong Kong, and every baby monitor sold through its online shop in the US for three consecutive years.

VTech has also partnered with local charities to support various charitable activities around the world. In FY2023, the Company made charitable and other donations of over US\$ 227,000. With the dedicated efforts and contributions to the charities, VTech was presented with "Heart to Heart Company" by the Hong Kong Federation of Youth Groups and the Company was the proud recipient of the "Outstanding Caring Awards (Enterprise Group)" presented by Federation of Hong Kong Industries in FY2023. VTech has also been awarded the "Caring Company" by The Hong Kong Council of Social Service for fifteen consecutive years in recognition of the continuous contribution to the Hong Kong community.



Collaboration with Save the Children

VTech recognises that attracting the best talents is important for the sustainable growth of the Company. It regularly recruits interns from local universities and organises various workshops with schools for the young people. The Company continues to offer the scholarship programme to universities in Hong Kong and mainland China.

VTech scholarships were awarded to 14 engineering students from five universities in Hong Kong including The University

of Hong Kong, The Hong Kong University of Science and Technology (HKUST), The Chinese University of Hong Kong (CUHK), City University of Hong Kong (CityU) and The Hong Kong Polytechnic University. In order to nurture the next generation of sustainability leaders, VTech has partnered with the School of Energy and Environment of CityU and Department of Mechanical and Automation Engineering of CUHK to organise the "VTech Innovation & Sustainability Award".

VTech has also joined with industry leaders at the "Made in Asia: Decarbonisation in Supply Chains" hybrid conference organised by The French Chamber of Commerce and Industry in Hong Kong to share its experience on integrating eco-design into the product life-cycle.

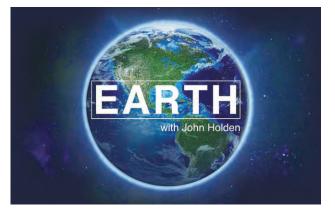

Prior to the COVID-19 pandemic, the Group conducted tours of its manufacturing facilities in mainland China to provide institutional shareholders with greater insight into its operations. Now that the situation is returning to normal and restrictions are no longer in place, the Group plans to resume this activity. This demonstrates the Group's commitment to transparency and its efforts to engage with shareholders and investors through open communication and providing opportunities to gain firsthand knowledge about its operations.

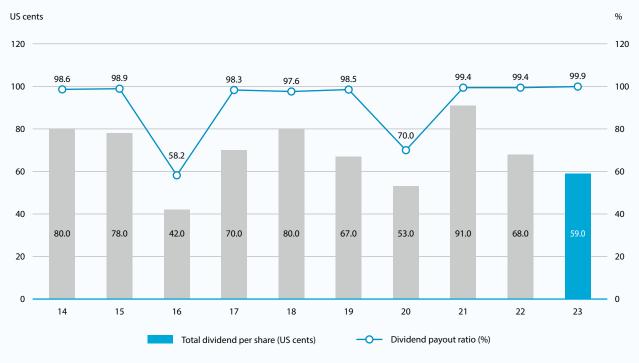
### **Shareholder Value**

Our goal is to create sustainable long-term value for our shareholders through a combination of regular dividend payments and share price performance. Our commitment to sustainability has been recognised through inclusion in a number of key indexes.

### **Dividend Payments**

The Group's dividend payout ratio is determined by various factors, including the actual and expected financial performance of the Group, global economic conditions, the Group's business strategies, liquidity position and capital requirements. We are committed to returning value to shareholders through dividend payments, with a consistently high dividend payout ratio. In eight of the past ten years, VTech has returned over 90% of its earnings to shareholders through dividend payments. In total, dividend payments during the past decade have amounted to US\$1,783.8 million.

The dividend payout ratio has been reduced only in response to unusual or special events. This occurred in the financial years 2016 and 2020 following the LeapFrog acquisition and during the COVID-19 crisis respectively.

In the financial year 2023, the dividend payout ratio was 99.9% of the profit attributable to shareholders of the Company, against 99.4% in the financial year 2022. Despite its high dividend payout ratio, VTech has consistently maintained a strong balance sheet and net cash position.

**Gordon CHOW**, aged 67, President of VTech Technologies Canada Ltd., is responsible for both the Telecommunication Product in North America and Electronic Learning Products in Canada. He established the Canadian operations in 1986. Mr. CHOW is a director of the Jays Care Foundation. He served as a member of the President's Advancement Council of British Columbia Institute of Technology and a director of the BCIT Foundation. He was also a member of the Royal Roads University – MBA Advisory Board, a director of the Canadian Toy Association and a member of the Board of Governors of Crofton House School in Vancouver. Mr. CHOW holds a Bachelor of Commerce degree from the University of British Columbia and was a member of the Institute of Chartered Accountants of British Columbia.

Alec Louis ANDERSON, aged 55, President of VTech Communications, Inc., is responsible for the Telecommunications Products in the United States. Mr. ANDERSON joined the Group in 2015 as the Vice President of Finance of the Telecommunications Products in the United States. Prior to joining the Group, he held executive management positions for over 25 years, with over 12 years in the consumer products industry. Mr. ANDERSON holds a Bachelor's degree in Business from California State University, San Bernardino.

The final dividend will be payable in United States dollars save that those shareholders with a registered address in Hong Kong will receive an equivalent amount in Hong Kong dollars which will be calculated at the rate of exchange as quoted to the Company by The Hong Kong and Shanghai Banking Corporation Limited at its middle rate of exchange prevailing on 21 July 2023.

Dr. William FUNG Kwok Lun has interests in 30,000 shares and 18,000 shares (each representing less than 0.01% of the total issued shares respectively) in the respective parent companies of the two companies which are the Group's five largest customers.

Save as disclosed above, as at 31 March 2023, as far as the Directors are aware, none of the Directors, their associates or any shareholders (which to the knowledge of the Directors own more than 5% of the Company's issued shares) had an interest in the customers and the suppliers noted above.

## Independent Auditor's Report



### To the Shareholders of VTech Holdings Limited

(Incorporated in Bermuda with limited liability)

### Opinion

We have audited the consolidated financial statements of VTech Holdings Limited ("the Company") and its subsidiaries ("the Group") set out on pages 94 to 138, which comprise the consolidated statement of financial position as at 31 March 2023, the consolidated statement of profit or loss, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2023 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### **Basis for opinion**

We conducted our audit in accordance with International Standards on Auditing ("ISAs") issued by the International Auditing and Assurance Standards Board ("IAASB"). Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the consolidated financial statements section of our report. We are independent of the Group in accordance with the International Ethics Standards Board for Accountants' International Code of Ethics for Professional Accountants (including International Independence Standards) ("the Code") together with any ethical requirements that are relevant to our audit of the consolidated financial statements in Bermuda, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### **Key audit matters**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

### Assessing the valuation of stocks

Refer to note 14 to the consolidated financial statements and the accounting policies on page 105.

### **The Key Audit Matter**

Stocks held at the year end comprise a wide range of products including electronic learning products and telecommunication products.

Sales of stocks in the electronic products industry can be volatile due to keen competition in the market and consumer demand frequently changing.

The Group typically sells or disposes of slow moving stocks at a markdown from the original price. Accordingly, the actual future selling prices of some items of stocks may fall below their cost.

Management assesses the net realisable value of slow moving and excess stocks with reference to the stock ageing report, anticipated future selling prices and / or sales forecasts. Stocks are written down to their net realisable value where this falls below their cost.

We identified the valuation of stocks as a key audit matter because determining appropriate stock write-downs involves predicting the excess quantities of stocks which will remain unused or unsold after the end of the reporting period and the markdowns necessary to sell such slow moving stocks, which can be inherently uncertain and which requires the exercise of significant management judgement.

### How the matter was addressed in our audit

Our audit procedures to assess the valuation of stocks included the following:

- evaluating the Group's stock write-down policy with reference to the requirements of the prevailing accounting standards;
- assessing whether the stock write-downs recognised at the reporting date were consistent with the Group's stock writedown policy by recalculating the stock write-downs based on the relevant parameters in the policy;
- examining the subsequent utilisation or release of stock write-downs recorded as at 31 March 2022 and additional write-down recognised in the current year in respect of stocks on hand as at 31 March 2022 to assess whether the judgement made by management in estimating the writedowns in the prior year indicated possible management bias;
- assessing, on a sample basis, whether items in the stock ageing report were classified within the appropriate ageing bracket by comparing individual items in the report with underlying documentation;
- enquiring of the director of each division and senior members of the sales team about any expected changes in plans for markdowns or disposals of slow moving stocks and comparing their representations with actual production and sales transactions subsequent to the reporting date; and
- evaluating, on a sample basis, whether stocks were stated at the lower of cost and net realisable value at the reporting date by comparing the sales prices of stocks subsequent to the reporting date with their carrying values as at 31 March 2023.

### Assessing potential impairment of goodwill

Refer to note 10 to the consolidated financial statements and the accounting policies on page 101.

### **The Key Audit Matter**

Management performs impairment assessments of the goodwill which arose from business combinations.

In performing such impairment assessments, management compares the carrying value of each of the separately identifiable cash-generating units ("CGUs") to which goodwill had been allocated with their respective recoverable amounts, being the higher of fair value less costs of disposal and value in use, to determine if any impairment loss should be recognised. Value in use is assessed based on discounted cash flow forecasts.

The preparation of discounted cash flow forecasts for the purpose of assessing value in use involves estimating future cash flows, growth rates and discount rates which can be inherently uncertain.

We identified the assessment of potential impairment of goodwill as a key audit matter because the year end goodwill impairment assessments performed by management contain certain judgemental assumptions which could be subject to management bias.

### How the matter was addressed in our audit

Our audit procedures to assess potential impairment of goodwill included the following:

- assessing the management's identification of CGUs, the allocation of assets to each CGU and the methodology adopted by management in its impairment assessments of goodwill with reference to the requirements of the prevailing accounting standards;
- evaluating the assumptions adopted in the preparation of the cash flow forecasts for the purpose of the impairment assessments of goodwill, including projected future growth rates for income and expenses, with reference to our understanding of the business, historical trends and available industry information and available market data;
- assessing whether the discount rates applied in the discounted cash flow forecasts prepared for the purpose of assessing potential impairment of goodwill were within a reasonable range by comparison with data for companies operating in the same industries;
- comparing the cashflow forecasts prepared at the end of last year for the purpose of impairment assessments with the actual performance of the businesses for the current year and make enquiries of management as to the reasons for any significant variations identified, to assess whether the judgement made by management in the preparation of the cash flow forecasts in the prior year indicated possible management bias; and
- assessing the impact of changes in the key assumptions, including projected profitability and the discount rates, adopted in the discounted cash flow forecasts on the conclusions reached in the impairment assessments and assessing whether there were any indicators of management bias in the selection of these assumptions.

# Information other than the consolidated financial statements and auditor's report thereon

The directors are responsible for the other information. The other information comprises all the information included in the annual report, other than the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Group to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision and performance of the group audit. We remain solely responsible for our audit opinion.

We communicate with the Audit Committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the Audit Committee with a statement that we have complied with relevant ethical requirements regarding independence and communicate with them all relationships and other matters that may reasonably be thought to bear on our independence and, where applicable, actions taken to eliminate threats or safeguards applied.

From the matters communicated with the Audit Committee, we determine those matters that were of most significance in the audit of the consolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

### **Principal Accounting Policies**

### A Principal Activities and Organisation

The Group's principal activities and operating segments are set out in note 1 to the consolidated financial statements.

The Company was incorporated in Bermuda. In view of the international nature of the Group's operations, the financial statements are presented in United States dollars.

### **B** Statement of Compliance

The consolidated financial statements have been prepared in accordance with all applicable International Financial Reporting Standards ("IFRSs"), which collective term includes all applicable individual International Financial Reporting Standards, International Accounting Standards ("IASs") and related Interpretations promulgated by the International Accounting Standards Board ("IASB").

These financial statements comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and the applicable disclosure provisions of the Listing Rules. A summary of the significant accounting policies adopted by the Group is set out below.

The IASB has issued certain amendments to IFRSs that are first effective or available for early adoption for the current accounting period of the Group:

- Amendments to IAS 16, Property, Plant and Equipment:
   Proceeds before Intended Use
- Amendments to IAS 37, Provisions, Contingent Liabilities and Contingent Assets: Onerous Contracts – Cost of Fulfilling a Contract

None of these developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

### C Basis of Preparation of the Financial Statements

The consolidated financial statements for the year ended 31 March 2023 comprise the Company and its subsidiaries and a structured entity (together referred to as the "Group") and the Group's interest in an associate.

These financial statements are prepared on the historical cost basis except that derivative financial instruments and investments are stated at their fair value as explained in the accounting policies set out below.

The preparation of the financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 29.

### D Basis of Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries and a structured entity and the Group's interest in an associate. All significant inter-company balances and transactions and any unrealised gains arising from inter-company transactions are eliminated on consolidation.

Subsidiaries (including structured entities) are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary and a structured entity is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment. The assets and liabilities of the structured entity, VTech Share Purchase Scheme Trust, are included in the Group's consolidated statement of financial position and the shares held by the VTech Share Purchase Scheme Trust are presented as a deduction from equity as Shares held for Share Purchase Scheme.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or a joint venture.

Investments in subsidiaries in the Company's statement of financial position are stated at cost less impairment losses (see note (N)(iii)). The financial results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

An associate is an entity in which the Group or Company has significant influence but not control or joint control, over its management, including participation in the financial and operating policy decisions.

### D Basis of Consolidation (Continued)

An investment in an associate is accounted for in the consolidated financial statements under the equity method, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). The cost of the investment includes purchase price, other costs directly attributable to the acquisition of the investment, and any direct investment into the associate that forms part of the Group's equity investment. Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see notes (H) and (N)(iii)). Any acquisition date excess over cost, the Group's share of the postacquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss and other comprehensive income.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee.

Unrealised profits and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

In the individual company's statement of financial position, investments in associates are stated at cost less impairment losses (see note (N)(iii)).

### E Revenue Recognition

Income is classified by the Group as revenue when it arises from the sale of goods and the provision of services.

Further details of the Group's revenue and other income recognition policies are as follows:

### (i) Revenue from contracts with customers

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

### Sale of goods

Revenue from sale of goods is recognised when the customer takes possession of and accepts the products. Payment terms and conditions vary by customers and are based on the billing schedule established in the contracts or purchase orders with customers. Where the contract contains a financing component which provides a significant financing benefit to the customer for more than 12 months, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction with the customer, and interest income is accrued separately under the effective interest method. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. The Group takes advantage of the practical expedient in paragraph 63 of IFRS 15 and does not adjust the consideration for any effects of a significant financing component if the period of financing is 12 months or less.

### (ii) Revenue from other sources and other income

### (a) Interest income

Interest income is recognised as it accrues using the effective interest method.

### (b) Dividend income

Dividend income is recognised when the Group's right to receive payment is established.

### (c) Government grants

Government grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

### F Research and Development

Research and development costs comprise all costs that are directly attributable to research and development activities or that can be allocated on a reasonable basis to such activities.

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

Expenditure on development activities is capitalised if the product or process is technically and commercially feasible, the attributable expenditure is separately identifiable and the Group has sufficient resources and the intention to complete development. The expenditure capitalised includes the cost of materials, direct labour and an appropriate proportion of overheads which are directly attributable to development activities. Capitalised development costs are stated at cost less accumulated amortisation and impairment losses (see note (N) (iii)). Development expenditure that does not meet the above criteria is recognised as an expense in the period in which it is incurred.

Amortisation is calculated to write off capitalised development costs on a straight-line basis over their estimated useful lives, commencing from the date when the products are put into commercial production.

### G Translation of Foreign Currencies

Foreign currency transactions during the year are translated into United States dollars at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into United States dollars at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transactions dates. The transaction date is the date on which the Group initially recognises such non-monetary assets or liabilities. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was determined.

The results of foreign operations are translated into United States dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into United States dollars at the closing foreign exchange rates at the end of the reporting period.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

### H Goodwill

Goodwill represents the excess of:

- the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the Group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash-generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see note (N)(iii)).

On disposal of a cash-generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

### I Business Combination

The Group applies the acquisition method to account for business combinations. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred to the former owners of the acquiree and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date. Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquire is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit or loss.

### J Tangible Assets and Depreciation

Tangible assets are stated at cost less accumulated depreciation and impairment losses (see note (N)(iii)).

Depreciation is calculated to write off the cost of assets on a straight-line basis over their estimated useful lives which are as follows:

Leasehold land	Over the unexpired term of lease
Medium-term and short-term leasehold buildings and leasehold improvements	10 to 50 years or lease term, if shorter
Moulds	1 year
Machinery and equipment	3 to 5 years
Computers, motor vehicles, furniture and fixtures	3 to 7 years

Where parts of a tangible asset have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

Items may be produced while bringing an item of tangible asset to the location and condition necessary for it to be capable of operating in the manner intended by management. The proceeds from selling any such items and the related costs are recognised in profit or loss.

Gains or losses arising from the retirement or disposal of tangible assets are determined as the difference between the estimated net disposal proceeds and the carrying amount of the assets and are recognised in profit or loss on the date of retirement or disposal.

### **K** Construction in Progress

Construction in progress represents land and buildings under development and is stated at cost less impairment losses (see note (N)(iii)). Cost comprises the construction costs of buildings and costs paid to acquire land use rights.

Building construction costs are transferred to leasehold buildings when the assets are completed and put into operational use and depreciation will be provided at the appropriate rates in accordance with the depreciation policies (see note (J)).

No depreciation or amortisation is provided in respect of construction in progress.

### L Intangible Assets

Intangible assets acquired in a business combination is recognised at fair value at the acquisition date. Intangible assets with finite useful life is stated at cost less accumulated amortisation and impairment losses (see note (N)(iii)).

### L Intangible Assets (Continued)

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. The following intangible assets with finite useful lives are amortised from the date they are available for use and their estimated useful lives are as follows:

Brand	30 years
Technology	5 years

Both the period and method of amortisation are reviewed annually.

### M Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a rightof-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a lowvalue asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see note (N)(iii)).

The initial fair value of refundable rental deposits is accounted for separately from the right-of-use assets in accordance with the accounting policy applicable to investments in debt securities carried at amortised cost (see notes (N)(i) and (O)(i)). Any difference between the initial fair value and the nominal value of the deposits is accounted for as additional lease payments made and is included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

### N Credit Losses and Impairment of Assets

### (i) Credit losses from financial instruments

The Group recognises a loss allowance for expected credit losses ("ECLs") on the financial assets measured at amortised cost (including deposits and cash, debtors and deposits).

Financial assets measured at fair value, including equity securities measured at fair value through profit or loss ("FVPL") and derivative financial assets, are not subject to the ECL assessment.

### Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls are discounted using the effective interest rate determined at initial recognition or an approximation thereof where the effect of discounting is material.

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade debtors are always measured at an amount equal to lifetime ECLs. ECLs on trade debtors are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

### N Credit Losses and Impairment of Assets (Continued)

### (i) Credit losses from financial instruments (Continued)

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

### Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

### Write-off policy

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off. Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

#### (ii) Credit losses from financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Financial guarantees issued are initially recognised at fair value (being the transaction price, unless the fair value can otherwise be reliably estimated). Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss.

The Group monitors the risk that the specified debtor will default on the contract and recognises a provision when ECLs on the financial guarantees are determined to be higher than the carrying amount in respect of the guarantees (i.e. the amount initially recognised, less accumulated amortisation).

To determine ECLs, the Group considers changes in the risk of default of the specified debtor since the issuance of the guarantee. A 12-month ECL is measured unless the risk that the specified debtor will default has increased significantly since the guarantee is issued, in which case a lifetime ECL is measured. The same definition of default and the same assessment of significant increase in credit risk as described in note (N)(i) apply.

As the Group is required to make payments only in the event of a default by the specified debtor in accordance with the terms of the instrument that is guaranteed, an ECL is estimated based on the expected payments to reimburse the holder for a credit loss that it incurs less any amount that the Group expects to receive from the holder of the guarantee, the specified debtor or any other party. The amount is then discounted using the current risk-free rate adjusted for risks specific to the cash flows.

#### (iii) Impairment of other assets

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- tangible assets;
- right-of-use assets;
- construction in progress;
- intangible assets;
- goodwill;
- interest in an associate, and
- investments in subsidiaries in the Company's statement of financial position.

If any such indication exists, the asset's recoverable amount is estimated. In addition, for goodwill, the recoverable amount is estimated annually whether or not there is any indication of impairment.

### N Credit Losses and Impairment of Assets (Continued)

- (iii) Impairment of other assets (Continued)
- Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit). A portion of the carrying amount of a corporate asset is allocated to an individual cash-generating unit if the allocation can be done on a reasonable and consistent basis, or to the smallest group of cash-generating units if otherwise.

### - Recognition of impairment losses

An impairment loss is recognised as an expense in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

- Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

### (iv) Interim financial reporting and impairment

Under the Listing Rules, the Group is required to prepare an interim financial report in compliance with IAS 34, *Interim Financial Reporting*, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

### **O** Other Investments

The Group's policies for investments in debt and equity securities, other than investments in subsidiaries and associate, are set out below.

Investments in debt and equity securities are recognised / derecognised on the date the Group commits to purchase / sell the investment. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at FVPL for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see note 23(e). These investments are subsequently accounted for as follows, depending on their classification.

### (i) Investments other than equity investments

Non-equity investments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method (see note (E)).
- Fair value through other comprehensive income ("FVOCI")

   recycling, if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of ECLs, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- Fair value through profit or loss ("FVPL"), if the investment does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

### (ii) Equity investments

An investment in equity securities is classified as FVPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an irrevocable election to designate the investment at FVOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVPL or FVOCI, are recognised in profit or loss as other income in accordance with the policy set out in note (E).

### P Stocks

Stocks are stated at the lower of cost and net realisable value. Cost is calculated on the weighted average or the first-in-first-out basis, and comprises materials, direct labour and an appropriate share of production overheads incurred in bringing the stocks to their present location and condition. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses.

When stocks are sold, the carrying amount of those stocks is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of stocks to net realisable value and all losses of stocks are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of stocks is recognised as a reduction in the amount of stocks recognised as an expense in the period in which the reversal occurs.

### **Q** Trade and Other Debtors

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset (see note (Y)).

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost, using the effective interest method and including allowance for credit losses (see note (N)(i)).

### R Cash and Cash Equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, short-term highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the statement of cash flows. Cash and cash equivalents are assessed for ECLs in accordance with the policy set out in note (N)(i).

### S Trade and Other Creditors

Trade and other creditors are initially recognised at fair value. Subsequent to initial recognition, trade and other creditors are stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

### T Provisions and Contingent Liabilities

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of past events, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Where some or all of the expenditure required to settle a provision is expected to be reimbursed by another party, a separate asset is recognised for any expected reimbursement that would be virtually certain. The amount recognised for the reimbursement is limited to the carrying amount of the provision.

### U Income Tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill not deductible for tax purposes and the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided that they are not part of a business combination).

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

### U Income Tax (Continued)

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities if, and only if, the Group has the legally enforceable right to set off current tax assets against current tax liabilities.

### V Employee Benefits

The Group operates a number of defined contribution retirement schemes throughout the world, including Hong Kong, and a defined benefit retirement scheme in Hong Kong. The assets of all schemes are held separately from those of the Company and its subsidiaries.

### (i) Defined contribution schemes

Contributions to the defined contribution schemes are at various funding rates that are in accordance with the local practice and regulations. Contributions relating to the defined contribution schemes are charged to profit or loss as incurred.

### (ii) Defined benefit scheme

The Group's net obligation in respect of defined benefit retirement scheme is calculated separately for each scheme by estimating the amount of future benefit that employees have earned in return for their service in the current and prior periods; that benefit is discounted to determine the present value and the fair value of any scheme assets is deducted. The calculation is performed by a qualified actuary using the projected unit credit method. When the calculation results in a benefit to the Group, the recognised asset is limited to the present value of economic benefits available in the form of any future refunds from the scheme or reductions in future contributions to the scheme.

Service cost and net interest expense (income) on the net defined benefit liability (asset) are recognised in profit or loss and are allocated by function as part of "cost of sales", "selling and distribution costs" or "administrative and other operating expenses". Current service cost is measured as the increase in the present value of the defined benefit obligation resulting from employee service in the current period. When the benefits of a scheme are changed, or when a scheme is curtailed, the portion of the changed benefit related to past service by employees, or the gain or loss on curtailment, is recognised as an expense in profit or loss at the earlier of when the scheme amendment or curtailment occurs and when related restructuring costs or termination benefits are recognised. Net interest expense (income) for the period is determined by applying the discount rate used to measure the defined benefit obligation at the beginning of the reporting period to the net defined benefit liability (asset). The discount rate is the yield at the end of the reporting period on high guality corporate bonds that have maturity dates approximating the terms of the Group's obligations.

Remeasurements arising from defined benefit retirement scheme are recognised in other comprehensive income and reflected immediately in revenue reserve. Remeasurements comprise actuarial gains and losses, the return on scheme assets (excluding amounts included in net interest on the net defined benefit liability (asset)) and any change in the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability (asset)).

### (iii) Equity and equity related compensation benefits

For share options granted under the 2021 Scheme and shares of the Company granted under the Shares Purchase Scheme ("Awarded Shares"), the fair value of share options and Awarded Shares granted to employees is recognised as an employee cost with a corresponding increase in the capital reserve and Shares held for Share Purchase Scheme, respectively, within equity. The fair value of share options is measured at grant date using the Black-Scholes option pricing model, taking into account the terms and conditions upon which the share options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share options or the Awarded Shares, the total estimated fair value of the share options and Awarded Shares are spread over the vesting period, taking into account the probability that the share options and Awarded Shares will vest.

During the vesting period, the number of share options and Awarded Shares that is expected to vest is reviewed. Any adjustment to the cumulative fair value recognised in prior years is charged / credited to profit or loss for the year of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the capital reserve and Shares held for Share Purchase Scheme, respectively. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of share options and Awarded Shares that vest (with a corresponding adjustment to the capital reserve and Shares held for Share Purchase Scheme) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount in respect of share options is recognised in the capital reserve until either the share option is exercised (when it is transferred to the share premium account) or the share option expires (when it is released directly to revenue reserve).

For those Awarded Shares which are amortised over the vesting periods, the Group revises its estimates of the number of Awarded Shares that are expected to ultimately vest based on the vesting conditions at the end of each reporting period. Any resulting adjustment to the cumulative fair value recognised in prior years is charged / credited to employee share-based compensation expense in the current year, with a corresponding adjustment to Shares held for Share Purchase Scheme.

### W Shares held for Share Purchase Scheme

Where the VTech shares are acquired by VTech Share Purchase Scheme Trust from the market, the consideration of shares acquired from the market (including any directly attributable incremental costs), is presented as Shares held for Share Purchase Scheme and deducted from total equity.

Upon vesting, the related costs of the vested Awarded Shares purchased from the market and shares acquired from reinvesting dividends received on the Awarded Shares ("dividend shares") are credited to Shares held for Share Purchase Scheme, with a corresponding increase in share-based payment expenses for Awarded Shares, and decrease in revenue reserve for dividend shares.

### Principal Accounting Policies (Continued)

#### W Shares held for Share Purchase Scheme (Continued)

For vesting of forfeited or unallocated shares regranted, the related costs of the forfeited or unallocated shares regranted are credited to Shares held for Share Purchase Scheme, and the related fair value of the shares regranted are debited to capital reserve. The difference between the cost and the fair value of the shares regranted is credited to share premium if the fair value is higher than the costs, or debited against revenue reserve if the fair value is less than the cost.

#### X Derivative Financial Instruments

Derivative financial instruments are recognised at fair value. At the end of each reporting period the fair value is remeasured. The gain or loss on remeasurement to fair value is recognised immediately in profit or loss, except where the derivatives qualify for cash flow hedge accounting, in which case recognition of any resultant gain or loss depends on the nature of the item being hedged.

#### Cash flow hedges

The Group designates certain derivatives as hedging instruments to hedge the variability in cash flows associated with highly probable forecast transactions arising from changes in foreign exchange rates (cash flow hedges).

Where a derivative financial instrument is designated as a hedging instrument in a cash flow hedge, the effective portion of any gain or loss on the derivative financial instrument is recognised in other comprehensive income and accumulated separately in equity in the hedging reserve. The ineffective portion of any gain or loss is recognised immediately in profit or loss.

If a hedge of a forecast transaction subsequently results in the recognition of a non-financial asset such as inventory, the associated gain or loss is reclassified from equity to be included in the initial cost of the non-financial asset.

For all other hedged forecast transactions, the amount accumulated in the hedging reserve is reclassified from equity to profit or loss in the same period or periods during which the hedged cash flows affects profit or loss (such as when a forecast sale occurs).

If a hedge no longer meets the criteria for hedge accounting (including when the hedging instrument expires or is sold, terminated or exercised), then the hedge accounting is discontinued prospectively. When hedge accounting is discontinued, but the hedged forecast transaction is still expected to occur, the amount that has been accumulated in the hedging reserve remains in equity until the transaction occurs and it is recognised in accordance with the above policy. If the hedged transaction is no longer expected to take place, the amount that has been accumulated in the hedging reserve is reclassified from equity to profit or loss immediately.

#### Y Contract Assets and Contract Liabilities

A contract asset is recognised when the Group recognises revenue (see note (E)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in note (N)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see note (Q)).

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note (E)). A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note (Q)).

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method (see note (E)).

#### Z Dividends

Dividends proposed or declared after the end of the reporting period are not recognised as a liability at the end of the reporting period.

#### **AA Segment Reporting**

Operating segments, and the amounts of each segment item reported in the financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purposes of allocating resources and performance assessment.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

The Group's customer base is diversified and include one (2022: three) customer with whom transactions have exceeded 10% of the Group's revenue. The revenue from this customer accounted for approximately 13% of the Group's revenue for the year ended 31 March 2023. For the year ended 31 March 2022, approximately 13%, 12% and 11% of the Group's revenue are derived from three external customers respectively. Such revenue is attributable to the North America segment.

#### (b) Segment Information

The Group manages its businesses by divisions, which are organised by geography. In accordance with IFRS 8 – *Operating segments* and in a manner consistent with the way in which information is reported internally to the Group's most senior executive management for the purposes of resource allocation and performance assessment, the Group has presented the following reportable segments.

- North America (including the United States and Canada)
- Europe
- Asia Pacific
- Other Regions, which covers sales of electronic products to the rest of the world

The Company is domiciled in Bermuda. The results of its revenue from external customers located in North America, Europe, Asia Pacific and elsewhere are set out in the table below.

Each of the above reportable segments primarily derives its revenue from the sale of electronic learning products, telecommunication products and products from contract manufacturing services to customers in the relevant geographical region.

All of these products are manufactured in the Group's manufacturing facilities located in the People's Republic of China ("PRC") and Malaysia under the Asia Pacific segment and Mexico under North America segment.

For the purposes of assessing segment performance and allocating resources between segments, the Group's senior executive management monitors the results and assets attributable to each reportable segment on the following bases:

#### (i) Segment revenues and results

Revenue is allocated to the reportable segment based on the location of external customers. Expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those geographical locations or which otherwise arise from the depreciation or amortisation of assets attributable to those segments.

The measure used for reporting segment profit is operating profit.

In addition to receiving segment information concerning operating profit, management is provided with segment information concerning revenue and depreciation and amortisation.

#### (ii) Segment assets and liabilities

Segment assets include all non-current assets and current assets with the exception of deferred tax assets, taxation recoverable and other corporate assets including intangible assets, goodwill, investments and interest in an associate.

Segment liabilities include creditors and accruals, provisions for defective goods returns and other liabilities and lease liabilities with the exception of taxation payable and deferred tax liabilities.

Having reviewed the merits of the additional tax assessments and taking into account legal advice received, the Directors have determined to strongly contest the additional assessments raised by the IRD. The Group has lodged objections against these additional tax assessments and has applied to hold over the additional tax demanded. The IRD has agreed to the holdover part of the additional tax demanded of US\$5.8 million subject to the purchase of tax reserve certificates ("TRCs") and has agreed to hold over the remaining balance of US\$4.7 million unconditionally. The purchase of TRCs do not prejudice of the Group's tax position. No additional tax provision has been made during the year ended 31 March 2023 in respect of the above additional tax assessments.

The Organisation for Economic Co-operation and Development ("OECD")/G20 Inclusive Framework on Base Erosion and Profit Shifting seeks to tackle tax avoidance, improve the coherence of international tax rules and ensure a more transparent tax environment. Global Anti-Base Erosion Model Rules (Pillar Two) ("BEPS 2.0") represents the first substantial overhaul of international tax rules in almost a century. It proposes mechanisms to ensure multi-national enterprises would pay a minimum level of tax with the rate of 15% on the income arising in each of the jurisdictions where they operate. The Group is closely monitoring the progress of the legislative process in each jurisdiction that the Group has operations. The purposes of the 2021 Share Option Scheme are to (i) attract potential employees; (ii) motivate and retain the eligible participants to support the Group's long term development; and (iii) to provide the Company with a flexible means of giving incentive to, rewarding, remunerating, compensating and/or providing benefits to the eligible participants for their contributions and/or potential contributions to the Group.

#### (ii) Participants

The eligible participants include Directors, officers and employees of any members of the Group as determined by the Board from time to time.

#### (iii) Total number of shares available for issue and percentage of issued shares

The total number of shares which may be issued upon exercise of all share options to be granted under the 2021 Share Option Scheme and any other share schemes of the Company must not in aggregate exceed 25,237,913 shares, being 10% of the shares issued as at 13 July 2021, the date of passing of an ordinary resolution of the shareholders adopted the 2021 Share Option Scheme.

The Company has granted share options to subscribe for 1,000,000 shares of the Company under the 2021 Share Option Scheme up to the date of this Annual Report. As at the date of this Annual Report, the total number of shares available for issue under the 2021 Share Option Scheme was 25,114,580 shares, representing approximately 9.94% of the total number of issued shares of the Company.

#### (viii) Basis of determining the subscription price

Subscription price (i.e the price per share at which a grantee may subscribe for shares on the exercise of a share option) shall be such price determined by the Board at its absolute discretion and notified to the participant in the offer of share option and shall be no less than the highest of:

- (1) the closing price of the shares as stated in the daily quotations sheet issued by the Stock Exchange on the date of grant;
- (2) the average closing price of the shares as stated in the daily quotations sheets issued by the Stock Exchange for the five (5) business days immediately preceding the date of grant; and
- (3) the nominal value of a share on the date of grant.

#### (ix) Remaining life

The 2021 Share Option Scheme has a life of 10 years and shall expire on 12 July 2031.

On 26 March 2013, the Company adopted the French Subplan. The shares to be awarded pursuant to the Share Purchase Scheme (the "Awarded Shares") will be granted to the eligible French employees of the Group pursuant to the Share Purchase Scheme and the French Subplan subject to the defined vesting period. The vesting period applicable under the French Subplan is currently not less than 1 year following the date of the award and a further 1 year sales restriction period as calculated from the date of the Awarded Shares being transferred to the eligible French employees. On 19 May 2015, the Company further amended and extended the Share Purchase Scheme such that the Company may furnish the trustee of the Share Purchase Scheme with cash to subscribe for the new shares under the general mandate of the Company (as approved by the shareholders at the annual general meeting of the Company) under the Share Purchase Scheme. The new shares, when issued and fully paid, will rank pari passu among themselves and with the shares currently in issue, pursuant to the Share Purchase Scheme.

A summary of the existing Share Purchase Scheme is set out below:

#### (i) Purposes

The purposes of the Share Purchase Scheme is to incentivise employees and to attract suitable personnel for the continuous development of the Group.

#### (ii) Participants

Eligible participants of the Share Purchase Scheme include Directors, officers and employees of any members of the Group as the Board or Remuneration Committee may determine or approve but shall exclude any person who at the relevant time has tendered his resignation or who is working out his period of notice pursuant to his employment contract or otherwise. An employee shall also be excluded if he is a resident in a place where the setting aside of sums of money and/or shares pursuant to the terms of the Share Purchase Scheme is not permitted under the laws and regulations of such place, or where in the view of the Board or the trustee (as the case may be) compliance with applicable laws and regulations in such place make it necessary or expedient to exclude such employees.

#### (iii) Total number of shares available for issue and percentage of issued shares

The scheme limit is 3% of issued share capital of the Company from time to time. The Board may resolve to increase such limit at its sole discretion. As at the date of this annual report, the total number of shares available for issue under the Share Purchase Scheme was 7,310,873 shares, representing approximately 3% of the total number of issued shares of the Company (excluding shares which have already been transferred to employees on vesting).

#### (iv) Maximum entitlement of each participant

There is no maximum entitlement of each participant under the Share Purchase Scheme.

#### (v) Vesting period of Awarded Shares granted

Save for the French Subplan as disclosed above, there is no minimum vesting period under the Share Purchase Scheme. Vesting of Awarded Shares under the Share Purchase Scheme will be conditional on, inter alia, the relevant selected employee remaining an employee of the Group until the vesting date. The Board also has the discretion to stipulate other conditions to vesting in respect of a particular selected employee.

#### (vi) Payment on acceptance of the Awarded Shares

No payment is required to be made by the eligible participants upon acceptance of the Awarded Shares.

#### (vii) Basis of determining the purchase price of Awarded Shares

Not applicable.

#### (viii) Remaining life

The Share Purchase Scheme shall be valid and effective for a term of 20 years from the Adoption Date and shall expire on 29 March 2031.

The total number of awards available for grant under the general mandate and the scheme limit pursuant to the Share Purchase Scheme as at 31 March 2022 and 31 March 2023 were 7,308,273 and 7,310,873 respectively.

The total number of shares that may be issued in respect of share options and awards granted under all share schemes of the Company during the financial year ended 31 March 2023 divided by the weighted average number of shares in issue for the year was 0.22%.

The Board proposed to make certain amendments to the Share Purchase Scheme to bring it in line with the amendments to Chapter 17 of the Listing Rules which came into effect on 1 January 2023 subject to the approval by the shareholders of the Company. A proposal will be made at the 2023 Annual General Meeting of the Company to seek the shareholders' approval of the amendments to the Share Purchase Scheme and the adoption of the amended Share Purchase Scheme.

#### (c) Share Purchase Scheme (Continued)

Pursuant to the Share Purchase Scheme, the total amount paid to purchase 252,000 shares (2022: 221,900 shares) on the Stock Exchange during the year ended 31 March 2023 was approximately US\$1.5 million (2022: US\$1.6 million). Further, 200,000 new shares (2022: 250,000 shares) were issued to the trustee under the general mandate of the Company pursuant to the Share Purchase Scheme at the price of US\$0.05 each.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The Group has no bank borrowings as at 31 March 2023 and 31 March 2022. Adjusted capital comprises all components of equity less unaccrued proposed dividends.

In order to monitor its capital structure, the Group may adjust the amount of dividends to be paid to shareholders, issue new shares, return capital to shareholders or raise new debt financing.

#### (c) Nature and purpose of reserves

The application of share premium account is governed by the Companies Act 1981 of Bermuda.

The exchange reserve comprises exchange differences arising from the translation of the financial statements of foreign operations.

The hedging reserve comprises the effective portion of the cumulative net change in fair value of hedging instruments used in cash flow hedges pending subsequent recognition of the hedged cash flows.

The capital reserve comprises the portion of the grant date fair value of unexercised share options granted to employees of the Company that has been recognised in accordance with the accounting policy adopted for share-based payments in note (V)(iii).

### 23 Financial Risk Management and Fair Values

Exposure to credit, currency, interest rate and liquidity risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

### (a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade debtors. The Group's exposure to credit risk arising from cash and cash equivalents and derivative financial assets is limited because the counterparties are banks, for which the Group considers to have low credit risk.

The Group does not provide any guarantees which would expose the Group to credit risk.

#### Trade debtors

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, 10.2% (2022: 13.2%) and 38.1% (2022: 39.8%) of the total trade debtors was due from the Group's largest customer and the five largest customers respectively.

The majority of the Group's sales are on letters of credit and on open credit with varying terms of 30 to 90 days. Certain open credit sales are covered by credit insurance or bank guarantees.

The Group measures loss allowances for trade debtors at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases. The following table provides information about the Group's exposure to credit risk and ECLs for trade debtors as at 31 March 2023 and 31 March 2022:

#### (b) Currency risk

The Group is exposed to currency risk primarily through sales and purchases that are denominated in currencies other than the functional currency of the operations to which they relate. As the Hong Kong Dollar ("HKD") is pegged to United States Dollar ("USD"), the Group does not expect any significant movements in the HKD/USD exchange rate. The currencies giving rise to foreign currency risk are primarily denominated in Euro ("EUR"), Pounds Sterling ("GBP"), Canadian dollars ("CAD"), Australian dollars ("AUD") and Renminbi ("RMB"). The Group manages this risk as follows:

#### (i) Hedges of foreign currency risk in forecast transactions

The Group uses forward exchange contracts to manage its currency risk until the settlement date of foreign currency receivables or payables. The Group designates those forward exchange contracts as hedging instruments in cash flow hedges and does not separate the forward and spot element of a forward exchange contract but instead designates the forward exchange contract in its entirety in a hedging relationship. Correspondingly, the hedged item is measured based on the forward exchange rate.

The Group enters into forward foreign exchange contracts in order to hedge the currency risk in respect of highly probable forecast sales transactions. Forward foreign exchange contracts are matched with anticipated future cash flows. As at 31 March 2023, the notional principal amounts of these outstanding forward foreign exchange contracts were US\$38.4 million (2022: US\$182.2 million) with net positive fair value of US\$2.2 million (2022: net positive fair value of US\$3.3 million) recognised as derivative financial instruments.

In addition, the Group uses forward foreign exchange contracts to hedge the exchange rate fluctuation for the purchase of RMB in respect of highly probable forecast transactions for the Group's PRC operations. Forward foreign exchange contracts are matched with anticipated future cash flows. As at 31 March 2023, the notional principal amounts of these outstanding forward foreign exchange contracts for hedging highly probable forecast transactions were US\$202.1 million (2022: US\$300.5 million) with net negative fair value of US\$3.3 million (2022: net positive fair value of US\$1.2 million) recognised as derivative financial instruments.

The Group does not anticipate any material adverse effect on its financial position resulting from its involvement in these financial instruments, nor does it anticipate non-performance by any of its counterparties.

The Group enters into derivative transactions under International Swaps and Derivatives Association (ISDA) master agreements providing offsetting mechanism under certain circumstances. At 31 March 2023 and 2022, the Group has not offset any of the financial instruments as no parties have exercised their rights to offset the recognised amounts in the financial statements. The Group applies a hedge ratio of 1:1 and determines the existence of an economic relationship between the forward exchange contracts and the highly probable forecast transactions based on their currency amounts and the timing of their respective cash flows. The main sources of ineffectiveness in these hedging relationships are:

- (a) the effect of the counterparty's and the Group's own credit risk on the fair value of the forward exchange contracts which is not reflected in the change in the value of the hedged cash flows attributable to the forward rate; and
- (b) changes in the timing of the hedged transactions.

Under these licensing agreements, the licensees are required to make royalty payments to the licensors, calculated as a percentage of net sales of the relevant character licensed products, subject to certain minimum aggregate royalty payments. ### **29 Accounting Estimates and Judgements**

The presentation of financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses.

Notes 10, 20 and 23 contain information about the assumptions and their risk factors relating to goodwill impairment, pension scheme obligations and fair value of financial instruments. Other key sources of estimation uncertainty are as follows:

#### Valuation of stocks

The Group performs regular reviews of the carrying amounts of stocks with reference to stock ageing report, anticipated future selling prices, sales forecasts and management experience and judgement. Based on this review, a write-down of stocks will be made when the estimated net realisable value of stocks decline below their carrying amounts. Due to changes in customers' preferences, actual saleability of goods may be different from estimation and the statement of profit or loss in future accounting periods could be affected by differences in this estimation.

#### Impairment of assets

The Group reviews internal and external sources of information at the end of each reporting period to identify indications that assets may be impaired or an impairment loss previously recognised no longer exists or may have decreased, except in the case of goodwill. The Group estimates the asset's recoverable amount when any such indication exists. In addition, for goodwill, the Group estimates the recoverable amount to determine whether or not there is any indication of impairment. The recoverable amount of an asset, or of the cash-generating unit to which it belongs, is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and these risks specific to the assets. The preparation of projected future cash flows involves the estimation of future revenue and operating costs which are based on reasonable assumptions supported by information available to the Group. Changes in the estimates would result in additional impairment provisions or reversal of impairment in future years.

#### Impairment of trade debtors

The Group's loss allowances are based on management's estimate of the lifetime expected credit losses, which is estimated by taking into account ageing of trade debtors and credit loss experience, adjusted for factors that are specific to the debtors, and an assessment of both the current and forecast general economic conditions at the report date. Changes in these estimates could have a significant impact on the loss allowance to be recognised or reversed in future years.

#### Provision for defective goods returns

The Group recognises provision for expected return claims, which included cost of repairing or replacing defective goods, loss of margin and cost of materials scrapped, based on past experience of the level of repairs and returns. The Group uses all available information in determining an amount that is a reasonable approximation of the costs including estimates based on reasonable historical information and supportable assumptions. Changes in these estimates could have a significant impact on the provision and could result in additional charges or reversal of provision in future years.
